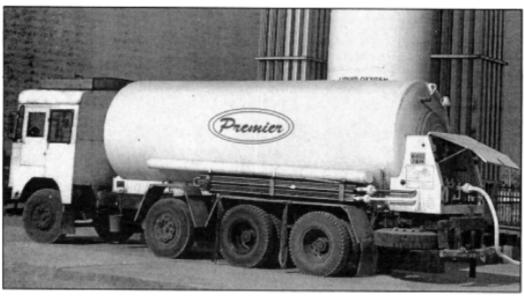

NOTICE is hereby given that the Thirtieth Annual General Meeting of the Members of Premier Cryogenics Ltd. will be held on Thursday the 29th August, 2024 at 3:30 P.M. (IST) through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") to transact the following business:

ORDINARY BUSINESS:

- To receive, consider and adopt the Audited (Standalone and Consolidated) Financial Statements of the Company for the financial year ended March 31, 2024 together with the Reports of the Board of Directors and Auditors thereon.
- 2) To declare Dividend on Equity Shares for the financial year ended March 31, 2024.
- To appoint a Director in place of Mrs. Anamika Chowdhary, (DIN: 00287195) who retires by rotation and being eligible offers herself for re-appointment.
- 4) To appoint auditors and fix their remuneration and in this regard to consider and if thought fit, to pass, with or without modification(s), the following resolution as an Ordinary Resolution:
 - "RESOLVED THAT pursuant to the provisions of Sections 139, 142 and other applicable provisions, if any, of the Companies Act, 2013 read with the Rules framed thereunder as amended from time to time (including any statutory modification(s) or re-enactment thereof for the time being in force) and based on the recommendation of the Audit Committee and the Board of Directors and having received the necessary consent and certificate pursuant to the aforesaid provisions, the existing auditors M/s. Singhi & Co., Chartered Accountants, (ICAI Firm Registration No. 302049E), be and are hereby appointed as the Statutory Auditors of the Company for the second term of five consecutive years, to hold office from the conclusion of this 30th Annual General Meeting (AGM) until the conclusion of the 35th AGM of the Company and that the Board of Directors be and are hereby authorized to fix the remuneration as may be determined by the Audit Committee in consultation with the auditors."

- 5) To appoint Mr. Raj Kumar More (DIN: 01917149) as a Director and in this regard to consider and if thought fit, to pass with or without modification(s), the following resolution, as an Ordinary Resolution:
 - "RESOLVED THAT pursuant to the provisions of sections 152, 160 and other applicable provisions, if any, of the Companies Act, 2013 read with the Rules made thereunder and the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended, Mr. Raj Kumar More (DIN: 01917149) who was appointed by the Board of Directors as an Additional Director of the Company with effect from 13/11/2023 and who holds office upto the date of this Annual General Meeting under Section 161 of the said Act, but who is eligible for appointment and having given his consent to act as Director, if appointed, and in respect of whom the Company has received a notice in writing from a member proposing his candidature for the office of Director under the provisions of Section 160 of the aforesaid Act and based on the recommendations of the Nomination and Remuneration Committee and the Board of Directors of the Company be and is hereby appointed as a Director of the Company liable to retire by rotation."

provisions of Regulation 23 and other applicable regulations of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended and in accordance with the approval and recommendation of the Audit Committee and of the Board of Directors of the Company, approval of the members be and is hereby accorded to enter into a contract/arrangement with M/s. Assam Air Products Pvt. Ltd. CIN:U24111AS1986PTC002497, (hereinafter referred to as "AAP" or the "Contractee Company"), a related party in which certain directors are interested, to continue with the transactions relating to sale of Industrial Gases by the Company to AAP for a period of three years effective from 01/04/2024 upto 31/03/2027 in line with the earlier contract/arrangement dated 01/04/2023 entered into by the Company with AAP for sale of Industrial gases, viz., Liquid Nitrogen, Oxygen, Dissolved Acetylene, Nitrous Oxide, Carbon Dioxide, etc. to the contractee company subject to maximum total amount of Rs.15.00 Cr. (Rupees Fifteen Crore only) for the period from 01/04/2024 to 31/03/2025, Rs.20.00 Cr (Rupees Twenty Crore only) for the period from 01/04/2025 to 31/03/2026 and Rs.25.00 Cr. (Rupees Twentyfive Crore only) for the period from 01/04/2026 to 31/03/2027 respectively and that the Board of Directors of the Company be and is hereby authorized to do all such acts and take all such steps as may be necessary, proper or expedient to give effect to this resolution and to carry out the contract/arrangement to the end and intent that the members shall be deemed to have given their approval thereto expressly by the authority of this resolution."

- The Ministry of Corporate Affairs ('MCA') has vide its General Circular Nos. 14/2020, 17/2020, 20/2020, 2/2022, 10/2022 and 09/2023 dated 8th April, 2020, 13th April, 2020, 5th May, 2020, 5th May, 2022, 28th December, 2022 and 25th September, 2023 respectively and the Securities and Exchange Board of India (SEBI) vide Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12th May, 2020, No. SEBI/HO/CFD/CMD2/CIR/P/ 2022/62 dated 13th May, 2022 and No. SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated 5th January, 2023 (collectively referred to as "the Circulars") permitted the holding of the Annual General Meeting ('AGM') through Video Conferencing ('VC') or Other Audio Visual Means ('OAVM'), without the physical presence of the Members at a common venue. In compliance with the provisions of the said Circulars and the provisions of the Companies Act, 2013 ('Act') and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the AGM of the Company is being held through VC/OAVM. The deemed venue for the AGM shall be the Registered Office of the Company.
- 2) PURSUANT TO THE PROVISIONS OF THE ACT, A MEMBER ENTITLED TO ATTEND AND VOTE AT THE AGM IS ENTITLED TO APPOINT A PROXY TO ATTEND AND VOTE ON HIS/HER BEHALF AND THE PROXY NEED NOT BE A MEMBER OF THE COMPANY. SINCE THIS AGM IS BEING HELD PURSUANT TO THE CIRCULARS THROUGH VC/OAVM, THE REQUIREMENT OF PHYSICAL ATTENDANCE OF MEMBERS HAS BEEN DISPENSED WITH. ACCORDINGLY, IN TERMS OF THE CIRCULARS, THE FACILITY FOR APPOINTMENT OF PROXIES BY THE MEMBERS WILL NOT BE AVAILABLE FOR THIS AGM AND HENCE THE PROXY FORM AND ATTENDANCE SLIP ARE NOT ANNEXED TO THIS NOTICE.
- Since the AGM shall be held through VC/OAVM, Attendance slip and the Route Map of the venue of the meeting is not annexed hereto.
- 4) DESPATCH OF NOTICE, ANNUAL REPORT THROUGH ELECTRONIC MODE: Pursuant to the MCA and SEBI Circulars mentioned above, the Notice of the 30th AGM and the Annual Report for the year 2023-2024, including therein the Audited Financial Statements for the said year, are being sent only by email to the Members. Therefore, those Members, whose email address is not registered with the Company or its RTA or with their respective Depository Participant(s), and who wish to receive the Notice and the Annual Report and all other communication sent by the Company, from time to time, can get their email address registered by following the steps as given below:



Instructions to register/update the Email ID:

a. For Members holding shares in Physical Form:

Those Members who are holding shares in physical form and have not updated their e-mail ids with the Company, are requested to update the same by submitting a duly filled and signed Form ISR-1 along with self-attested copy of the PAN Card and self-attested copy of the document(s) as prescribed in the said form in support of the address of the Member, to the Company/RTA.

b. For Members holding shares in Demat Form:

Please contact your Depository Participant (DP) and register your email address.

- 5) The Notice of the 30th AGM and the Annual Report for the year 2023-24 will be available on the website of the Company at www.premiercryogenics.com. Physical copies of the Notice and Annual report will be sent only if any specific request is received by the Company from any of its members.
- 6) The Register of Members and Share Transfer Books of the Company shall remain closed from Friday the 23rd August, 2024 to Thursday the 29th August, 2024 both days inclusive.
- The Instructions for participation by Shareholders in the AGM through VC/OAVM and E-Voting are given in the subsequent paragraphs.

8) CDSL e-Voting System – For e-voting and Joining Virtual meetings

- As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings
 of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA)
 vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020, Circular No.
 20/2020 dated May 05, 2020. The forthcoming AGM will thus be held through video conferencing (VC) or
 other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM through
 VC/OAVM.
- 2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020, May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
- 3. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to atleast 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
- The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
- Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM through VC/OAVM and cast their votes through e-voting.
- 6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM has been uploaded on the website of the Company at www.premiercryogenics.com. The Notice can also be accessed from the websites of the Stock Exchange i.e. Calcutta Stock Exchange at www.cse-india.com. The AGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM) i.e. www.evotingindia.com.
- The AGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.



In continuation of this Ministry's General Circular No. 20/2020 dated 05.05.2020, General Circular No. 02/2022 dated 05.05.2022 and General Circular No. 10/2022 dated 28.12.2022 and after due examination, it has been decided to allow companies whose AGMs are due in the Year 2023 or 2024, to conduct their AGMs through VC or OAVM on or before 30th September, 2024 in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020.

THE INSTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:

- Step 1 :Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.
- Step 2 : Access through CDSL e-Voting System in case of Shareholders holding shares in physical mode and non-individual shareholders in demat mode.
- (i) The voting period begins on 26th August, 2024 (9:00 AM IST) and ends on 28th August, 2024 (5:00 PM IST). During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of 22nd August, 2024, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No.SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1: Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

(iv) In terms of SEBI Circular No.SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

- (vi) After entering these details appropriately, click on "SUBMIT" tab.
- (vii) Shareholders holding shares in physical form will then directly reach the Company selection screen. However, shareholders holding shares in demat form will now reach 'Password Creation' menu wherein they are required to mandatorily enter their login password in the new password field. Kindly note that this password is to be also used by the demat holders for voting for resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential.
- (viii) For shareholders holding shares in physical form, the details can be used only for e-voting on the resolutions contained in this Notice.

- (x) On the voting page, you will see "RESOLUTION DESCRIPTION" and against the same the option "YES/NO" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- (xi) Click on the "RESOLUTIONS FILE LINK" if you wish to view the entire Resolution details.
- (xii) After selecting the resolution, you have decided to vote on, click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- (xiii) Once you "CONFIRM" your vote on the resolution, you will not be allowed to modify your vote.
- (xiv) You can also take a print of the votes cast by clicking on "Click here to print" option on the Voting page.

He is a graduate in commerce and is the founder Director of Torsa Machines Ltd. and also founder of N.E. Farmcare Technologies and has vast experience in business with operational, marketing and managerial expertise. He is also a Director in Torsa Equipment Pvt. Ltd. Metalment Overseas Pvt. Ltd. and Bolt Hammer Pvt. Ltd. It is, therefore, proposed to appoint Mr. More as a Director of the Company. Mr. Raj Kumar More, being eligible for the appointment has given his consent to act as Director, if appointed at the ensuing AGM. As required u/Sec. 160 of the Companies Act, 2013 and Company's Articles of Association, the Company had received a notice in writing from a member signifying his intention to propose the candidature of Mr. Raj Kumar More for the office of Director liable to retire by rotation and his appointment has been recommended by the Nomination and Remuneration Committee and by the Board of Directors of the Company. It is, therefore, proposed to appoint Mr. More as a Director of the Company liable to retire by rotation as per the said recommendations for approval in the ensuing AGM. Item No. 6

The Company entered into a contract/arrangement dated 01/04/2023 with M/s Assam Air Products Pvt. Ltd. (CIN:U24111AS1986PTC002497), a related party, (hereinafter referred to as "AAP" or the "Contractee Company") for sale of Industrial gases, viz., Liquid Nitrogen, Oxygen, Dissolved Acetylene, Nitrous Oxide, Carbon Dioxide, etc. The contract/arrangement was for a period of one year w.e.f. 01/04/2023 to 31/03/2024 and was entered in accordance with the omnibus approval of the Audit Committee preceded by approval of the Board of Directors pursuant to the provisions of Section 188 and other applicable provisions of the Companies Act, 2013 and Regulation 23 and other applicable regulations of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, as amended.

In view of the aforesaid contract/arrangement having expired on 31/03/2024, and considering it desirable and of immense necessity in the best interest of the Company, it is proposed to continue with the transactions and enter into a renewed contract/arrangement in line with the earlier contract/arrangement for sale of Industrial gases to AAP for a period of 3 (three) years from 01/04/2024 to 31/03/2027 subject to maximum total amount per annum. Under the previous contract/arrangement, the aggregate value of transactions was approved at Rs.9.50 Cr. only for the year 2023-24 in accordance with the threshold limit prescribed for omnibus approval under Regulation 23 and other applicable provisions of the SEBI Listing Regulations. But such monetary limit will not be adequate to cover the aggregate value of transactions in the following year(s) considering the prospective rate of growth in the scale of operations of the Company and the Contractee party and the future projections and estimates. Therefore, approval of the Members is sought to the proposed contract/arrangement



for a period of three years subject to the maximum total amount of the transactions per annum of Rs.15.00 Cr. for the year 2024-25, Rs.20.00 Cr for the year 2025-26 and Rs.25.00 Cr. for the year 2026-27. These incremental limits have been proposed keeping in view the future growth in demand and the scale of operations of the Company. The prices for the industrial gases shall be at the prevailing market rates which are based on the rates at which such goods are sold to PSUs like ONGC and Govt. Depts.

The Contract has been considered to be very much essential due to the following reasons:

- i. PCL is the largest manufacturer of industrial gases in the N.E. Region and its two Oxygen/Nitrogen manufacturing units have increased the total installed capacity of the Company. Thus, with its large production facilities, PCL can cater to the entire needs for industrial gases of the contractee company (AAP). Further AAP has a large inventory of cylinders and cryogenic transport tankers for bulk lifting of products which are very much beneficial for PCL's plant capacity utilization and saving additional investment in cylinders and cryogenic tankers.
- ii. The contractee company AAP is the largest dealer of industrial gases in the N.E. India and in addition to the market demand, it will also have its own continuous good growing demand for the requirement of industrial gases for its new Compressing units, which will help PCL's plant capacity utilization and sales volume to a great extent.
- iii. The contract is of necessity for marketing the products and utilizing the Company's installed production capacity and thereby to maintain the scale of operation of the Company and remain viable.

In accordance with the provisions of Section 188 and other applicable provisions of the Companies Act, 2013, the Companies (Meetings of Board and its Powers) Rules, 2014 and the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Member's approval by way of special resolution is required for entering into the said contract/arrangement. Accordingly, the proposed resolution is placed for approval of the members. Pursuant to the aforesaid provisions, the Board of Directors of the Company accorded its consent vide resolution dated 28/05/2024 preceded by approval of the Audit Committee in terms of the aforesaid provisions and as per the Company's policy on related party transactions. The Contractee Company AAP had given their no objection for entering into the said contract.

In terms of the proviso to subsection (2) of Section 102 of the Companies Act, 2013, the shareholding interest of every promoter, director and key managerial personnel to the extent of two percent or more of the paid-up share capital of the contractee company AAP are of Mr. Abhijit Barooah, Promoter and Managing Director holding 20,47,180 equity shares and Mrs. Anamika Chowdhary, Promoter and Director holding 4,73,920 equity shares being 45.493% and 10.532% shareholding respectively in the paid-up share capital of the Contractee Company.

DEAR MEMBERS,

We have the pleasure in presenting the Thirtieth Annual Report and the Audited Financial Statements of the Company for the year ended 31st March, 2024.

Note: The Company's subsidiary being not in active operation, there was no difference between the consolidated and standalone total revenue during the year.

OPERATIONAL PERFORMANCE

During the year under report, the Company's overall operations were carried out satisfactorily inspite of a stiff competitive environment. Demand for Industrial and Medical gases showed an upward trend compared to the previous year and both the manufacturing units of the Company could be run optimally. The Company was also providing the facility of in-house oxygen plants for generating Oxygen gas at several medical establishments across the N.E. region which also contributed towards improving the scale of operations of the Company. Production and sale of Nitrous Oxide and Carbon Dioxide gases have increased during the year while production of Dissolved Acetylene was marginally lower compared to the previous year. Besides its gas manufacturing activities, the Company was also carrying out construction business in the healthcare sector. The Company is hopeful of higher growth in demand from the industrial and medical gases sectors and looks forward to better operational performance in the coming year.

FINANCIAL PERFORMANCE

During the year, the Company's revenue from operations was ₹ 7301 lakh which dropped by about 6% compared to ₹ 7748 lakh of the previous year. This was mainly because of lower revenue from construction business due to completion of most of the contractual projects. Profit before tax of ₹ 1567 lakh was marginally lower by about 3% compared to ₹1616 lakh of previous year while Net profit after tax of ₹ 1220 lakh was about the same compared to ₹ 1219 lakh of the previous year. During the year, the Company had received Government incentives under NEIIP and State industrial policy aggregating ₹ 538 lakhs which contributed towards the profitability. The Company expects that with stable economic conditions and better industrial climate, the Company's overall financial performance will improve in the years to come.



The Company has been maintaining excellent track record with banks. The Company is availing term loan and working capital facilities from SBI. From the end of the financial year till the date of this report, the Company has been timely servicing the aforesaid term loan and working capital facilities, as before. During the year under review, the Company was rated "BBB+" by the rating agency CARE for the Company's borrowings.

The financial statements for the year ended March 31, 2024 has been prepared in accordance with the Indian Accounting Standard (Ind AS) notified under Section 133 of the Companies Act, 2013 read with the Companies (Accounts) Rules, 2014. The estimates and judgments relating to the Financial Statements are made on a prudent basis, so as to reflect in a true and fair manner, the form and substance of transactions and reasonably present the Company's state of affairs, profits and cash flows for the year. The Notes to the financial statements adequately cover the standalone and consolidated Audited Statements which are made an integral part of this report.

There are no material changes and commitments affecting the financial position of the Company from the end of the financial year to the date of this report.

STATE OF AFFAIRS OF THE COMPANY

During the year under review, the Company was engaged in the business of manufacture, trading, services and construction of facilities of industrial& medical gases. The Company continued its operations in the industrial and health care sectors and supplies were satisfactorily made to the clients, mostly from the core sector oil & gas, hospitals, food and beverage industries and in the infrastructure sector mainly within the N E Region and nearby states. The Company's products are Oxygen, Nitrogen, Dissolved Acetylene, Nitrous Oxide and Carbon Dioxide which in the aggregate contributed revenue of 76.60% of the Company's total turnover during the year. Revenue from services was 8.77% of the total turnover. Other Operating revenue consisting of Government incentives contributed about 7.36% while Income from construction was 7.27% of the total turnover. There has been no change in the nature of business of the Company during the year.

FUTURE PLANS & PROSPECTS

Looking at the present industrial scenario and improvement in the overall economic activities, the Company envisages better scope for growth in the gas business in the coming years. Special efforts are being put to improve its scale of operations, capacity building and entering potential markets for industrial and medical gases across the N.E. Region and beyond. Possible growth is anticipated in the activities of the core sector oil industries, railways, infrastructure, power and health care sectors under the Government initiated projects. Steps are being taken to strengthen the Company's existing manufacturing facilities at Samaguri and Saukuchi in the State of Assam and cater to the needs of consumers. Possibilities are also being explored to set up a new plant and position the Company to meet the future growth in demand. The Company also expects good growth in its construction business in the health care and oil sector in the near future. With its adequate engineering capabilities and technical expertise of successfully executing several industrial infrastructure and pipeline projects, the Company is hopeful of bagging similar contracts in this specialized area. However, the Company keeps itself open to realign its activities as per the industry demands and reassess the impact on its business operations, which may tend to deviate from its current estimates and assumptions. The Company expects that with growing industrial activities and better economic conditions together with proactive policies of the Government, it will have better prospects in the years to come.

DIVIDEND

The Board of Directors are pleased to recommend a dividend of 15% per share, ie., ₹ 1.50 per share on the 49,23,900 fully paid up Equity Shares of ₹ 10 each for the financial year 2023-2024.

TRANSFER TO INVESTOR EDUCATION & PROTECTION FUND

During the year under report, the Company transferred the amount of dividend lying unpaid or unclaimed for a period of seven years to the Investor Education & Protection Fund (IEPF). Further, pursuant to the provisions of Section 124(6) of the Companies Act, 2013, all shares in respect of which unpaid or unclaimed dividend has been transferred as aforesaid has also been transferred by the Company in the name of IEPF Authority except the shares of those investors who have communicated with the company before such transfer.

TRANSFER TO RESERVES

The Company proposes to transfer ₹200.00 lakh to the General Reserve out of amount available for appropriation and ₹944.48 lakh is proposed to be retained in the Statement of Profit and Loss.



PARTICULARS OF LOANS, GUARANTEES AND INVESTMENTS

The Company has not given any loan, guarantee or provided any security in connection with a loan to any person or other body corporate (other than its wholly owned subsidiary company) during the year. Current investments of surplus funds were made in quoted Mutual Fund. Advances given to suppliers, Govt. depts., etc. were in the ordinary course of business. Advances to related parties were not material in nature. Details of loans, guarantees and investments covered under the provisions of Section 186 of the Act are given in the notes to Financial Statements forming part of this Annual Report.

The Company is availing working capital (cash credit) facilities of a limit of ₹400 lakh and a Non-fund based (bank guarantee) limit of ₹500 lakh from SBI. The Company is availing from SBI under Arogyam scheme cash credit of ₹800 lakh and term loan of ₹86 lakh and GECL of ₹491 lakh. The Company has not made any application nor is any proceeding pending under the Insolvency and Bankruptcy Code, 2016 during the year. Further, there is no proposal for one time settlement of any loan taken from any Banks or FIs. The Company has been timely servicing the aforesaid term loan and working capital facilities.

ISSUE OF SHARES

During the year, the Company did not make any issue of shares. As on 31st March, 2024, the issued, subscribed and paid-up share capital was ₹492 lakh comprising 49,23,900 equity shares of ₹10/- each. The shares continued to be listed on the Calcutta Stock Exchange and Listing fees have been paid for the year 2023-24. During the year, the Company also paid a fine to the Exchange due to delay in submission of few compliance documents earlier during the Covid pandemic period and the Exchange had revoked the suspension imposed during the year. The Company has arrangements with NSDL and CDSL to provide the facility to shareholders for dematerialization of their shares.

DEPOSITS

The Company has not accepted deposits in terms of Section 73 of the Companies Act, 2013 read with Companies (Acceptance of Deposits) Rules, 2014.

HOLDING, SUBSIDIARY& ASSOCIATE COMPANIES

The Company does not have any holding, associate or joint venture company other than a subsidiary company, viz., PCL Power Pvt. Ltd. which is yet to commence its operational activities. The Company is not a material subsidiary as per the threshold laid down under the Listing Regulations. The Company has a policy for determining material subsidiary and the same is available in the Company's website: www.premiercryogenics.com.

PERFORMANCE OF SUBSIDIARY COMPANY

PCL Power Private Limited was incorporated as a subsidiary company primarily with the objective of venturing into the business of generating power by procuring Natural gas from the OIL sector companies. The Company carried out surveys and has been exploring the possibilities of procuring Natural gas to generate the requisite power. Bids were submitted to the Oil & Gas sector Companies but the Company could not succeed so far. Efforts are being continued and the Company is hopeful of being successful in its bids and commence operations. The Company is also exploring the possibility of venturing into the solar power business.

In accordance with the provisions of the first proviso to Section 129(3) read with Rule 5 of the Companies (Accounts) Rules, 2014, a statement containing salient features of the financial statement of the Subsidiary Company in prescribed Form AOC-1 is given in Annexure – I.

RELATED PARTY TRANSACTIONS

During the year 2023-24, the Company entered into a contract/arrangement dated 01/04/2023 with M/s. Assam Air Products Pvt. Ltd. (a related party)for sale of industrial gases for a period of one year after obtaining omnibus approval of the Audit Committee and prior approval of the Board in accordance with the provisions of Section 188 of the Companies Act, 2013, Rules thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. In view of the contract/arrangement having expired, and considering it desirable and of immense necessity, it is proposed to continue with the transactions and enter into a renewed contract/arrangement for a period of three years. Under the previous contract/arrangement, the total value of transactions was approved at Rs.9.50 Cr. only as per the threshold limit prescribed for omnibus approval under Reg. 23 of the Listing Regulations. But as such limit will be inadequate for the coming year(s), it is proposed to enter into a similar contract/arrangement for



three years subject to maximum total amount per annum of Rs.15.00 Cr. for the year 2024-25, Rs.20.00 Cr. for the year 2025-26 and Rs.25.00 Cr. for the year 2026-27 subject to approval of the Members. These incremental limits have been considered in view of the projections and estimates of future growth in demand and scale of operations of the Company. Details of the proposal have been set out in the Notice of AGM for approval of the Members.

The Company also continued with its earlier contract/arrangement dated 01/04/2023 with the aforesaid related party for a period of one year ie., 2023-24 for availing services of installation and commissioning in the execution of supply, installation and commissioning contracts of PSA Oxygen plants in Medical colleges and hospitals across India. For the year 2024-25, the Company proposes to continue with similar contract/arrangement with the related party for one year. The contract/arrangement will be as per statutory provisions after obtaining omnibus approval of the Audit Committee and prior approval of the Board in accordance with the provisions of the Companies Act, 2013, Rules made thereunder, the SEBI Listing Regulations and the Company's policy on related party transactions.

During the year, the Company had also entered into a contract/arrangement with one of the Company's Director, Mrs. Anamika Chowdhary, a related party, for taking on rent of a part of a building for the purpose of setting up of Company's office. The contract/arrangement has been entered initially for a period of one year from 01/12/2023 to 30/11/2024 after obtaining omnibus approval of the Audit Committee and prior approval of the Board in accordance with the provisions of the Companies Act, 2013, Rules made thereunder, the SEBI Listing Regulations and the Company's policy on related party transactions.

The Company has a policy on related party transactions pursuant to the provisions of the Companies Act, 2013 and the SEBI Listing Regulations and the same has been disclosed in the Corporate policies report under the Corporate Governance report section to this Annual report and also disclosed in the Company's website: www.premiercryogenics.com. Further, pursuant to Section 134(3)(h) of the Companies Act, 2013 and Rule 8(2) of the Companies (Accounts) Rules, 2014, particulars of the contracts/arrangements in prescribed Form AOC-2 are given in Annexure – II to this report.

SIGNIFICANT AND MATERIAL ORDERS PASSED BY THE REGULATORS

During the year under review, no significant and material orders were passed by the regulators or courts or tribunals impacting the going concern status and company's operations.

The internal financial controls of the Company with reference to the financial statements are adequate, commensurate with the size and nature of business of the Company.

During the year under review, there was no instance of fraud which required the Statutory Auditor to report to the Audit Committee and/or the Board under Section 143(12) of the Companies Act, 2013 and Rules made thereunder.

RISK MANAGEMENT

The Company has formulated a Risk Management Policy based on its assessment of business risks generally and those specific to the industry. The policy has been formulated keeping in view the size of the Company and nature of its business and in line with the requirements of the Companies Act, 2013 and the Listing Regulations. The policy takes into consideration potential risks including operational risks, price fluctuation risks, regulatory risks, strategic risks, financial risks, human resource risks, etc., and enables the Company to address the same through mitigating actions in a systematic manner and on a continual basis. DIRECTORS

MANAGEMENT DISCUSSION & ANALYSIS

MANAGEMENT DISCUSSION & ANALYSIS

OVERVIEW:

During the year 2023-24, the overall performance of the Company was satisfactory. Inspite of a stiff competitive environment, the Company could maintain operations and cater to the demand for industrial and medical gases from the Oil & gas and healthcare sectors. Demand for Industrial and Medical gases showed an upward trend compared to the previous year and both the manufacturing units of the Company could be run optimally. The Company was also providing the facility of in-house oxygen plants at several Medical establishments across the N.E. Region which also contributed towards improving the scale of operations of the Company. Total production from the Oxygen/Nitrogen plants was 270.87 lakh cum which was up by 15% compared to the previous year. The Company's Oxygen production during the year was 169.73 lakh cum which grew by 19% compared to the previous year. Industrial Oxygen gas sale of 16.93 lakh cum increased by 24% mainly because of improvement in industrial activities while sale of Medical Oxygen gas of 15.93 lakh cum increased by about 8% compared to the previous year. Sale of Liquid Qxygen during the year was 95.61 lakh cum which was lower by about 3% compared to previous year. Sale of Nitrogen aggregating 112.49 lakh cum, mainly to the oil sector, grew by about 1% compared to 111.01 lakh cum of previous year. Dissolved Acetylene sale of 1.44 lakh cum dropped by 11% while Nitrous Oxide sale of 1.63 lakh cum increased by about11% over the previous year. Sale of Carbon Dioxide of 6.74 lakh kg increased by about 20% compared to 5.62 lakh kg of the previous year. The Company was also carrying out construction business in the healthcare sector which has also contributed towards the Company's operational performance. The Company remains hopeful that with growing industrial activities, better economic conditions and pro-active policies of the Government, it will be able to improve its performance in the years to come.

INDUSTRY STRUCTURE & DEVELOPMENTS:

Premier Cryogenics has been operating in the industrial gases industry for more than two and a half decades. Over the period, the Company had acquired wide experience and expertise in the industrial and medical gas sectors in respect of changes in technology and trend of growth and has been able to tap potential markets within the NE Region and beyond. Over the years, the Company could capitalize its long standing experience in the industry with proven track records and technical expertise in the field of gas production, distribution, bottling and construction of facilities in the oil & gas and healthcare sectors and has been able to penetrate the emerging markets and operate successfully. With its bigger and better manufacturing facilities, the Company had positioned itself to cater to the market demand and meet the needs of a variety of consumers mainly from the core sector oil industries, State Vety, deptts, research laboratories, Railways, Food processing, Infrastructure and Health care sectors and maintain its leading position mainly in the N.E. region. The Company is presently catering to about 70% of the market demand of the region. With its proven capabilities, the Company is confident of maintaining its leading position and continue its business operations successfully. Besides its primary business of manufacture and trading of industrial, medical and other gases, the Company is also engaged in carrying out projects relating to construction of facilities in the gas sector and could successfully execute several pipeline and infrastructure projects in the oil & gas industries and setting up of PSA Oxygen plants in several medical establishments across the N.E. region. With improvement in overall industrial activities, the Company looks forward to a better industrial gas market in the coming years.

OPPORTUNITIES, THREATS, RISKS & CONCERNS:

Being in a specialized industry, the Company has a variety of opportunities. But at the same time, it is exposed to several threats and risks specific to the industry. The main products, Oxygen & Nitrogen are produced by atmospheric air separation having no raw-material cost. Sale of Dissolved Acetylene has the potential of increasing Oxygen sale due to their joint applications. The Company has the locational advantage of having its manufacturing facilities at Guwahati, the hub centre of the region, and at Samaguri in middle Assam and enjoys comparatively lower freight cost and stable power supply. The Samaguri unit being a latest technology energy efficient plant, the Company enjoys comparatively lower power cost reducing the unit cost of production and giving competitive advantage. The promoters being highly experienced technocrats, the Company has the potential for growth and development. The gas products being critical inputs for the industrial and medical gas users have good growing demand.



MANAGEMENT DISCUSSION & ANALYSIS (Contd.)

Inspite of the opportunities, the Company identifies certain potential risks and threats specific to the industry. Manufacture of O2/N2 is critically dependent on power. Any disruption in its supply will adversely affect production. Further, any hike in tariff will inflate the unit cost of products. Calcium Carbide, a major input for DA, is sourced from distant States having the risk of erratic supply and price escalation. The Company supplies mainly through open tenders which are subject to market competition. The Company enjoys benefits relating to tax refunds and other incentives as per the Government Industrial policies. Any change in policy or non-receipt of incentives will affect performance. The Company's business activities are critically dependent on the economic activities of several core sector industries. Any adversities in their performance either due to industry specific causes or general economic slowdown will adversely affect its performance. With gradual improvement in the overall economic conditions supported by proactive policies of the Government, the Company is hopeful of overcoming the potential risks and threats and operate successfully.

SEGMENT WISE OR PRODUCT WISE PERFORMANCE:

The Company operates in a single business or geographical segment engaged in the business of manufacture and trading of industrial, medical and other gases and in construction of facilities in the Industrial & Medical gas sector. The Company's main products include Oxygen, Nitrogen; Dissolved Acetylene and Nitrous Oxide. During the year, Industrial Oxygen gas sale of 16.93 lakh cum grew by 24% while Medical Oxygen gas sale of 15.93 lakh cum increased by 8%.ButLiquid Oxygen sale of 95.61 lakh cum dropped by 3% compared to the previous year. Sale of Nitrogen of 112.49 lakh cum which was sold mainly to customers from the Oil sector grew by about 1% compared to 111.01 lakh cum of the previous year. Dissolved Acetylene sale of 1.44 lakh cum declined by 11% compared to the previous year while sale of Nitrous Oxide of 1.63 lakh cum increased by about 11%. Sale of Carbon Dioxide of 6.74 lakh kg increased by about 20% compared to the previous year. The growth in sale of industrial gases was mainly due to improvement in industrial activities bringing demand from the local industries, Railways, and infrastructure sector compared to the previous year. The Company expects that with improvement in industrial activities and better economic conditions, it will be able to increase its overall performance in the coming years.

INTERNAL CONTROL SYSTEMS:

The Company has adequate internal control systems commensurate with the nature and size of its business. The control systems are reviewed periodically and are improved upon as per requirement of the activities, particularly relating to sale of goods, purchase of stores, raw materials and other assets in line with the Company's policy on risk management. The Company has installed computer based systems with requisite software for specific job execution processes and on-line facilities were used in all the functional units. These measures have resulted in better internal checks and controls and facilitate real-time reporting and recording of transactions. The internal control system is supplemented by regular internal audits. Review of actions taken on the audit observations are done periodically.

The internal audit report and financial statements are reviewed by the Audit Committee of the Company on a quarterly basis. The observations of the Committee are acted upon by the Management. This has improved the Company's internal reporting process and its review and monitoring systems.

FINANCIAL PERFORMANCE:

During the year, the Company's overall financial performance was satisfactory. It could carry out the fiscal plans and policies and maintain financial stability and liquidity in its operations and meet the financial commitments on time. Adequate systems were put in place for regular monitoring and analysis of the fund flows including supply credits, recoveries, debts and repayments. The Company's total revenue for the year was ₹7301 lakh which was lower by about 6% compared to the previous year. This was mainly because of lower revenue from construction business due to completion of most of the contractual projects. Profit before finance cost, depreciation and amortization was ₹2183 lakh and net profit before tax of ₹1567lakh was lower by about 3%compared to previous year as the major expenses like Power Cost and Distribution expenses were higher during the year. The Company has been maintaining profitability and paying dividend continuously for last several years. The key indicators of the Company's performance compared

to earlier years are annexed to this report. The Company is hopeful that with increase in industrial activities and better market conditions, its financial performance will improve in the coming years.

The Company has been servicing its term loans from SBI. Working capital is being availed from SBI with cash credit facility of ₹400 lakh and a Non-fund based (bank guarantee) limit of ₹500lakh from SBI. The Company is availing from SBI under Arogyam scheme cash credit of ₹800 lakh and term loan of ₹86 lakh and GECL of ₹491 lakh. The Company has a credit rating of "BBB+" from the credit rating agency CARE and is maintaining excellent track record with banks and FIs.

INDUSTRIAL RELATIONS & HUMAN RESOURCE MANAGEMENT:

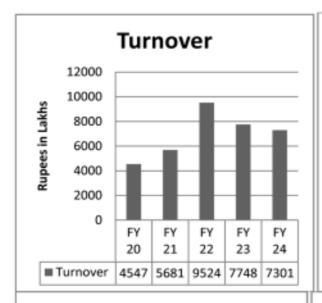
During the year, the Company continued to take special initiative for building effective manpower at all the organizational levels. Emphasis was given on manpower planning; allocation of suitable personnel for respective jobs and induction of new personnel in various functional departments. Steps were taken for recruitment and selection of skilled manpower and identifying and placement of requisite personnel at various locations including the contractual project sites and the Company's plant operating units. Special focus was given on individual skills, talents and experiences aligned to the respective jobs. Efforts were also continued for overall development of human resources in technical, managerial and administrative fields. In this process, the Company continues to review and improve its HR policies and practices. Amongst the regular HR activities, there were trainings and familiarization programmes, performance reviews, implementation of remunerative and incentives schemes such as productivity linked bonus, rewards, felicitation of employees, etc. The Company's Nomination and Remuneration Committee oversees the HR practices as per laid down policies. Relationships with employees were cordial throughout the year. The Directors acknowledge the efforts put in by the employees to improve the Company's level of performance during the year.

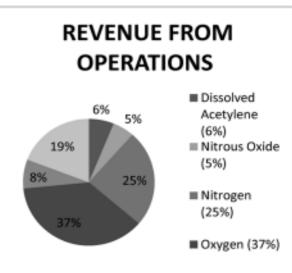

CORPORATE POLICIES AND REPORTS

In accordance with the provisions of the Companies Act,2013, the Stock Exchange Listing Agreement and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company adopted a Whistle Blower policy as a part of vigil mechanism, policy for managing risks, policy for Nomination and Remuneration, code for dealing in share and fair conduct; dealing with related party transactions, policy for determining material subsidiary, Corporate Social Responsibility policy, Documents preservation policy and a Code of conduct for the Company. Disclosure about the Company's policies and reports are given below:

Whistle Blower Policy

The Company has adopted a Whistle Blower Policy as a part of vigil mechanism to provide the Directors and employees in senior management of the Company with a mechanism to bring to the attention of the management any issue which is perceived to be in violation of or in conflict with the fundamental business principles and code of conduct of the Company. The policy provides for reporting such concerns through written communications to the Company and also makes provision for giving access to the Chairperson of the Audit Committee in appropriate and exceptional cases. Any case registered by the Company under the policy shall be subject to the review of the Audit Committee.

Policy on Risk Management

The Company has a Risk Management procedure based on its assessment of business risks generally and those specific to the industry. The policy on risk management has been formulated keeping in view the size of the Company and nature of its business and in line with the requirements of the Companies Act, 2013 and the Listing Regulations. It enables the Company to assess the risks identified through the business processes and functions, and address the same through mitigating actions in a systematic manner and on a continual basis. Some of the identified risks relate to the economic adversities, competitive intensity and cost volatility. It takes into consideration a variety of risk factors such as market conditions, distribution and supply systems, geographical and social factors, financial, technical, legal and other compliance related factors. During the year, the Company could maintain its level of performance by identifying and aligning its facilities to meet the growing demand from the industrial sector, while at the same time, it continued to cater to the needs from the healthcare sector in the post pandemic scenario with comparatively lower demand for medical gases thereby enabling the

Company to reduce the risk of a fall in its scale of operations and maintain optimum product mix. The Company also continued to optimally utilize its engineering capabilities and technical expertise for carrying out its construction business in the oil and gas and healthcare sectors. With these untiring efforts, the Company could maintain its level of performance and overall scale of operations during the year. The Company is operating its new technology plant at Samaguri which comparatively lower power cost thereby reducing the unit cost of production. The Company also carries out in-house plant maintenance and development of certain equipment parts as a measure for import substitution and hedging costs. These measures have enabled the Company to remain competitive and reduce the risk of sustainability in a competitive market environment. The Company also lays emphasis for improvement in its internal control systems commensurate with the size and nature of its business. These systems are reviewed periodically and recommendations by Audit Committee and Audit observations are taken into consideration for strengthening the risk management practices.

Nomination and Remuneration Policy

The Company has adopted a Nomination and Remuneration Policy pursuant to the provisions of Companies Act,2013 and the Regulations. This policy has been formulated as a guide relating to appointment, remuneration, retirement and removal of Director(s), Key Managerial Personnel and Senior Management personnel. It interalia focuses on identifying and ascertaining the integrity, qualification, expertise and experience of the person for appointment. It also lays down the policy on Board diversity, criteria for selection, appointment, remuneration, retirement and removal of Directors and KMPs, the terms and tenure for the Managing Director/Whole-time director and the independent directors. The policy also serves as a guide for the review and evaluation of performance of the Board and of the individual directors. It also covers the senior management personnel and other employees of the Company.

Policy for dealing with related party transactions

As per requirements of the Companies Act, 2013 and Listing Regulations, the Company formulated a policy on Related party transactions to ensure that proper reporting, approval and disclosure processes are in place for the transactions between the Company and related parties. The policy deals with the review and approval of material related party transactions keeping in view the conflict of interest that may arise because of entering into these



transactions. It guides in ascertaining the materiality of contracts or arrangements entered into by the Company with related parties in relation to the nature and size of the transactions and also those which are carried out in the ordinary course of business or relating to arm's length transactions, if any. The Related party transactions are placed before the Audit Committee for review and approval of the Board and Shareholders and disclosed as per provisions of the Companies Act, 2013, the rules thereunder and the Listing regulations.

Policy for determining material subsidiaries

As per Regulation 16(1)(c) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had formulated a policy for determining material subsidiaries, as may be required from time to time. The policy has been adopted to determine the material subsidiary(ies) of the Company upon identifying the same and to provide the governance framework for such subsidiary company(ies). It interalia defines the materiality of a subsidiary, representation on its board, role of the Company's Audit Committee relating to its subsidiary, role of the management, and disposal of the material subsidiary.

Code of fair disclosure and conduct

Pursuant to the SEBI Regulations on prohibition of insider trading, the Company has adopted the Code for fair disclosure and conduct to establish a mechanism to restrict insider trading in shares of the Company. The Code prohibits the Directors of the Company and other specified employees dealing in the securities of the Company on the basis of any unpublished price sensitive information, available to them by virtue of their position in the Company. The Code prevents misuse of any unpublished price sensitive information and prohibits any insider trading activity, in order to protect the interest of the shareholders of the Company.

CSR Policy

In accordance with the provisions of Section 135 of the Companies Act, 2013 read with Rule 3 of the Companies (Corporate Social Responsibility Policy) Rules, 2014 and Rule 9 of the Companies (Accounts) Rules, 2014, the Company had earlier constituted a CSR Committee and also adopted a policy on CSR. The Company's CSR policy is a guide for conducting its business with social responsibility and accountability. It lays down a systematic and dedicated approach towards implementing CSR projects or programmes for improving the quality of life of the people and society primarily in the areas in which it operates. It describes the focus areas and the methodology for implementation, governance, funding, monitoring and reporting the activities.

During the year 2023-24, the Company undertook CSR activities in the areas of Rural road development projects in the district of Nagaon, Assam where the Company has its business operations. As per the aforesaid provisions, an Annual report on the CSR activities carried out during 2023-24 is annexed to the Board's report.

Document Preservation and Archival Policy

In accordance with Regulation 9 of the SEBI Listing Regulations, the Company has framed a Policy for Preservation and Archival of Documents. The objective of the policy is to classify the documents of the Company, for determining their preservation period, into two categories: (a) documents whose preservation shall be permanent in nature; and (b) documents with preservation period of not less than eight years. The policy also acts as a guide for determining the period for retention and retrieval of commercial and legal records in accordance with the needs of the company, statutory and other legal requirements including various aspects of disposal/destruction of the documents.

It is aimed for achieving excellence in all its dealings including standards of business conduct and is committed to highest standards the of Corporate Governance. NOTES TO FINANCIAL STATEMENTS

Notes to the financial statements for the year ended March 31, 2024

1. Company Information

Premier Cryogenics Limited (the 'Company') is a public limited company domiciled in India with its registered office at 136, Maniram Dewan Road, Chandmari, Guwahati 781 003. The Company is listed on the Calcutta Stock Exchange (CSE). The Company is operating in the Industrial & Medical Gases business comprising primarily of Oxygen, Nitrogen, Medical oxygen, Nitrous oxide, Dissolved Acetylene in Eastern India. The Company has manufacturing facilities at Guwahati and Samaguri in Assam and sells primarily in Eastern India through independent distributors and direct sales. It also provides services and carries out construction business in Industrial & Medical Gases sector.

2. Basis of Preparation, Measurement and Significant Accounting Policies

2.1 Basis of Preparation

These financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'Ind AS') as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current or non-current classification of assets and liabilities.

The financial statements are presented in INR, the functional currency of the Company. Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates (the 'functional currency').

2.2 Basis of measurement

These financial statements are prepared under the historical cost convention unless otherwise indicated.

2.3 SIGNIFICANT ACCOUNTING POLICIES

a) Property, plant and equipment

Property, Plant and Equipment are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. Such cost includes the cost of replacing part of the Plant and Equipment and borrowing costs for long-term construction projects if the recognition criteria are met. When significant parts of plant and equipment are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives. All repair and maintenance costs are recognised in profit or loss as incurred.

Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as "Capital work-in-progress".

An item of Property, Plant and Equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is derecognised.

Depreciation on Property, Plant and Equipment is provided based on useful life of the assets prescribed in Schedule II to the Companies Act, 2013. However, any deviation from the useful life as prescribed in Schedule II to the Companies Act, 2013 and actual life of the assets shall be disclosed. Depreciation methods, useful lives and residual values are reviewed periodically, including at each financial year end and adjusted prospectively, if appropriate.

b) Intangible assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated amortisation/depletion and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use and net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the intangible assets.

Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in the Statement of Profit or Loss when the asset is derecognised.

Intangible assets comprising of Software are amortised over the period of 5 years.

c) Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/non-current classification. An asset is current when:

- . Expected to be realised or intended to be sold or consumed in the normal operating cycle;
- . Held primarily for the purpose of trading;



- . Expected to be realised within twelve months after the reporting period; or
- . Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is current when:

- . It is expected to be settled in the nornal operating cycle;
- . It is held primarily for the purpose of trading;
- . It is due to be settled within twelve months after the reporting period; or
- . There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

d) Inventories

Inventories are valued at lower of cost or net realisable value. Cost is determined on weighted average basis. Cost of inventories comprises all costs of purchase, duties and taxes (other than those subsequently recoverable from tax authorities) and all other costs incurred in bringing the inventory to their present location and condition. Cost of finished goods and work-in-progress includes the cost of materials, conversion costs, an appropriate share of fixed and variable production overheads and other costs incurred in bringing the inventories to their present location and condition. Net realisable value represents the estimated selling price in the ordinary course of business less all estimated costs of completion and costs necessary to make the sale.

Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are disclosed under Capital Work-in-Progress.

e) Impairment of Non- Financial Assets

The Company assesses at each reporting date as to whether there is any indication that any property, plant and equipment and intangible assets or group of assets, called eash generating units (CGU) may be impaired. If any such indication exists the recoverable amount of an asset or CGU is estimated to determine the extent of impairment, if any. When it is not possible to estimate the recoverable amount of an individual assets, the Company estimates the recoverable amount of the (CGU) to which the asset belongs. An impairment loss is recognised in the Statement of Profit and Loss to the extent, asset's carrying amount exceeds its recoverable amount. The recoverable amount is higher of an asset's fair value less cost of disposal and value in use. Value in use is based on the estimated future cash flows, discounted to their present value using pre-tax discount rate that reflects current market assessments of the time value of money and risk specific to the assets. The impairment loss recognised in prior accounting period is reversed if there has been a change in the estimate of recoverable amount.

f) Provisions and Contingent Liabilities

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

g) Employee Benefits

Defined Contribution Plans

Provident Fund and ESIC contributions are made to the respective regulatory authorities. The Company makes specified monthly contributions towards Provident Fund and Employees State Insurance Corporation. The Company's contribution is recognised as an expense in the Statement of Profit and Loss during the period in which the employee renders the related service.

Defined Benefit Plans

The Company pays gratuity to the employees whoever has completed five years of service with the company at the time of resignation/superannuation. The gratuity is paid @15 days salary for every completed year of service as per the Payment of Gratuity Act 1972.

The gratuity liability amount is contributed to Life Insurance Corporation of India under Group Gratuity Scheme for employees. The gratuity fund has been approved by respective IT authorities. The liability in respect of gratuity and other post-employment benefits is calculated using the Projected Unit Credit Method and spread over the period during which the benefit is expected to be derived from employees' services.



h) Tax Expenses

The tax expense for the period comprises current and deferred tax. Tax is recognised in the Statement of Profit and Loss, except to the extent that it relates to items recognised in the comprehensive income or in equity. In which case, the tax is also recognised in other comprehensive income or equity.

Current Tax

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates and laws that are enacted or substantively enacted at the Balance sheet date.

Deferred tax

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The carrying amount of Deferred tax liabilities and assets are reviewed at the end of each reporting period.

i) Foreign currencies transactions and translation

Transactions in foreign currencies are recorded at the exchange rate prevailing on the date of transaction. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency closing rates of exchange at the reporting date. Exchange differences arising on settlement or translation of monetary items are recognised in Statement of Profit and Loss.

j) Revenue recognition

Revenue from sale of goods is recognised when all the significant risks and rewards of ownership in the goods are transferred to the buyer as per the terms of the contract, there is no continuing managerial involvement with the goods and the amount of revenue can be measured reliably. The Company retains no effective control of the goods transferred to a degree usually associated with ownership and no significant uncertainty exists regarding the amount of the consideration that will be derived from the sale of goods. Revenue is measured at fair value of the consideration received or receivable, after deduction of any trade discounts and any taxes or duties collected on behalf of the government which are levied on sales such as sales tax, value added tax, goods and services tax, etc.

Income from services rendered is recognised based on agreements/ arrangements with the customers as the service is performed in proportion to the stage of completion of the transaction at the reporting date and the amount of revenue can be measured reliably.

Revenue from EPC is recognised on the basis of stage of completion by reference to surveys of work performed.

Interest income from a financial asset is recognised on time basis, by reference to the principal outstanding at the effective interest rate applicable, which is the rate which exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition. Insurance claims are recognised to the extent there is a reasonable certainty of the realizability of the claim amount.

Dividend income is recognised when the Company's right to receive the payment has been established.

k) Government Grants

Government grants are recognised when there is reasonable assurance that they will be received and the Company will comply with the conditions associated with the grants. Grants that compensate the company for expenses incurred are recognised in profit or loss, either as other operating income or deducted in reporting the related expense, as appropriate, on a systematic basis over the periods in which the Company recognises as expenses the related costs for which the grants are intended to compensate. Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Company with no future related costs are recognised in profit or loss in the period in which they are received. As per Ind AS 20, government grants related to assets, shall be presented in the Balance Sheet by setting up the grant as deferred income. In subsequent year this deferred government grant will be amortised over the useful life of the assets.

I) Financial instruments

Financial Assets

A.Initial recognition and measurement:

All financial assets and liabilities are initially recognized at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities, which are not at fair value through profit or loss, are adjusted to the fair value on initial recognition. Purchase and sale of financial assets are recognised using trade date accounting.



B. Subsequent measurement

i) Financial assets carried at amortised cost (AC)

A financial asset is measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

ii) Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

iii) Financial assets at fair value through profit or loss (FVTPL)

A financial asset which is not classified in any of the above categories are measured at fair value through profit or loss.

m) Equity Investments

All equity investments are measured at fair value, with value changes recognised in statement of profit and loss, except for those equity investments for which the company has elected to present the value changes in 'Other Comprehensive Income'.

Impairment of Financial Assets.

In accordance with Ind AS 109, the Company uses 'Expected Credit Loss' (ECL) model, for evaluating impairment of financial assets other than those measured at fair value through profit and loss (FVTPL). Expected credit losses are measured through a loss allowance at an amount equal to:

i.The 12-months expected credit losses (expected credit losses that result from those default events on the financial instrument that are possible within 12 months after the reporting date); or

ii.Full lifetime expected credit losses (expected credit losses that result from all possible default events over the life of the financial instrument)

For trade receivables company applies 'simplified approach' which requires expected lifetime losses to be recognised from initial recognition of the receivables. Further the company uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward looking estimates are analysed. For other assets, the company uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

o) Financial liabilities

Initial recognition and measurement:

All financial liabilities are recognized initially at fair value and in case of loans net of directly attributable cost. Fees of recurring nature are directly recognised in the Statement of Profit and Loss as finance cost.

Subsequent measurement:

Financial liabilities are carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

De-recognition of financial instruments

The Company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire or it transfers the financial asset and the transfer qualifies for derecognition under Ind AS 109. A financial liability (or a part of a financial liability) is derecognized from the company's balance sheet when the obligation specified in the contract is discharged or cancelled or expires.

p) Expenditures

Expenses are accounted on accrual basis.

q) Earnings Per Share

Basic earnings per share is computed by dividing the net profit for the period attributable to the equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period and for all periods presented is adjusted for events, such as bonus shares, other than the conversion of potential equity shares that have changed the number of equity shares outstanding, without a corresponding change in resources.

For the purpose of calculating diluted earnings per share, the net profit for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

Notes on Consolidated financial statements for the year ended March 31, 2024

1. Company Information

Premier Cryogenics Limited (the 'Company') is a public limited company and it's subsidiary domiciled in India with its registered office at 136, Maniram Dewan Road, Chandmari, Guwahati 781 003. The Company is listed on the Calcutta Stock Exchange (CSE). The Company is operating in the Industrial & Medical Gases business comprising primarily of Oxygen, Nitrogen, Medical oxygen, Nitrous oxide, Dissolved Acetylene in Eastern India. The Company has manufacturing facilities at Guwahati and Samaguri in Assam and sells primarily in Eastern India through independent distributors and direct sales. It also provides services and carries out construction business in Industrial & Medical Gases sector.

2. Basis of Preparation, Measurement and Significant Accounting Policies

2.1 Basis of Preparation

These financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'Ind AS') as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current or non-current classification of assets and liabilities.

The financial statements are presented in INR, the functional currency of the Company. Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates (the 'functional currency').

2.2 Basis of measurement

These financial statements are prepared under the historical cost convention unless otherwise indicated.

2.3 SIGNIFICANT ACCOUNTING POLICIES

a) Principles of Consolidation

The Consolidated Financial Statement ("CFS") relate to Premier Cryogenics Limited ("the Company") and it's subsidiary (the company and it's subsidiary collectively referred to as "the Group"). The Consolidated Financial Statement have been prepared on the following basis:

- i) The financial statements of the Company and its subsidiary Companies are combined on a line by line basis by adding together the book values of like items of assets, liabilities, income and expenses, after fully eliminating intra group balances and intra group transactions resulting in unrealised profits or losses in accordance with Indian Accounting Standard 110 - "Consolidated Financial Statements".
- ii) The consolidated financial statements are prepared to the extent possible by using uniform accounting policies for like transactions and other events in similar circumstances and are presented in the same manner as the Company's separate financial statements except as otherwise stated.

b)The subsidiary company PCL Power Private Limited is included in the consolidation and the Company's holding therein is 100%

2.4 OTHER SIGNIFICANT ACCOUNTING POLICIES

These are set out under "Significant Accounting Policies" as given in the Company's separate financial statement.
