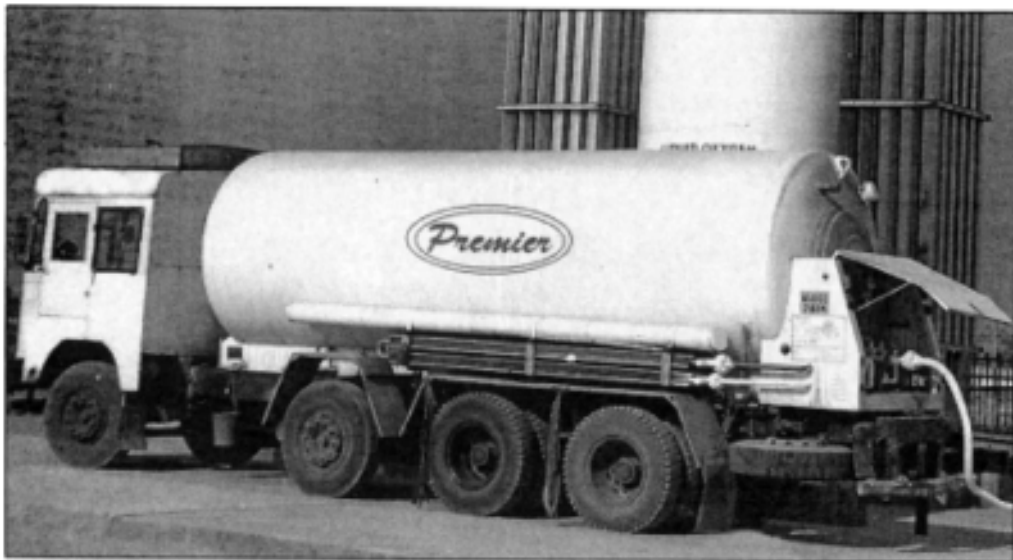

- 1) The Ministry of Corporate Affairs ('MCA') has vide its General Circular No. 03/2025 dated 22nd September, 2025 (in continuation with the earlier circulars issued in this regard) allowed the holding of the Annual General Meeting ('AGM') through Video Conferencing ('VC') or Other Audio Visual Means ('OAVM'), without the physical presence of the Members at a common venue. In compliance with the provisions of the said Circulars and the provisions of the Companies Act, 2013 ('Act') and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the AGM of the Company is being held through VC/OAVM. The deemed venue for the AGM shall be the Registered Office of the Company.
- 2) PURSUANT TO THE PROVISIONS OF THE ACT, A MEMBER ENTITLED TO ATTEND AND VOTE AT THE AGM IS ENTITLED TO APPOINT A PROXY TO ATTEND AND VOTE ON HIS/HER BEHALF AND THE PROXY NEED NOT BE A MEMBER OF THE COMPANY. SINCE THIS AGM IS BEING HELD PURSUANT TO THE CIRCULARS THROUGH VC/OAVM, THE REQUIREMENT OF PHYSICAL ATTENDANCE OF MEMBERS HAS BEEN DISPENSED WITH. ACCORDINGLY, IN TERMS OF THE CIRCULARS, THE FACILITY FOR APPOINTMENT OF PROXIES BY THE MEMBERS WILL NOT BE AVAILABLE FOR THIS AGM AND HENCE THE PROXY FORM AND ATTENDANCE SLIP ARE NOT ANNEXED TO THIS NOTICE.
- 3) Since the AGM shall be held through VC/OAVM, Attendance slip and the Route Map of the venue of the meeting is not annexed hereto.
- 4) **DESPATCH OF NOTICE, ANNUAL REPORT THROUGH ELECTRONIC MODE:** Pursuant to the MCA and SEBI Circulars and the earlier announcements on Green initiatives, the Notice of the 32nd AGM and the Annual Report for the year 2025-2026, including therein the Audited Financial Statements for the said year, are being sent only by email to the Members. Therefore, those Members, whose email address is not registered with the Company or its RTA or with their respective Depository Participant(s), and who wish to receive the Notice and the Annual Report and all other communication sent by the Company, from time to time, can get their email address registered by following the steps as given below:

Instructions to register/update the Email ID:

a. For Members holding shares in Physical Form:

Those Members who are holding shares in physical form and have not updated their e-mail ids with the Company, are requested to update the same by submitting a duly filled and signed Form ISR-1 along with self-attested copy of the PAN Card and self-attested copy of the document(s) as prescribed in the said form in support of the address of the Member, to the Company/RTA.

b. For Members holding shares in Demat Form:

Please contact your Depository Participant (DP) and register your email address.

- 5) The Notice of the 32nd AGM and the Annual Report for the year 2025-26 will be available on the website of the Company at www.premiercryogenics.com. Physical copies of the Notice and Annual report will be sent only if any specific request is received by the Company from any of its members.
- 6) The Register of Members and Share Transfer Books of the Company shall remain closed from Monday the 24th August, 2026 to Saturday the 29th August, 2026 both days inclusive.
- 7) The Instructions for participation by Shareholders in the AGM through VC/OAVM and E-Voting as provided by CDSL are given in the subsequent paragraphs.

8) CDSL e-Voting System – For e-voting and Joining Virtual meetings

1. As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020. The forthcoming AGM will thus be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM through VC/OAVM.
2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020, May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
3. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
5. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM through VC/OAVM and cast their votes through e-voting.
6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM has been uploaded on the website of the Company at www.premiercryogenics.com. The Notice can also be accessed from the websites of the Stock Exchange i.e. Calcutta Stock Exchange at www.cse-india.com. The AGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM) i.e. www.evotingindia.com.
7. The AGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.

8. In continuation of this Ministry's **General Circular No. 20/2020** dated 05.05.2020, General Circular No. 02/2022 dated 05.05.2022 and General Circular No. 10/2022 dated 28.12.2022 and after due examination, it has been decided to allow companies whose AGMs are due in the Year 2024 or 2025, to conduct their AGMs through VC or OAVM on or before 30th September, 2024 in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020.

THE INSTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

Step 2 : Access through CDSL e-Voting System in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on 26th August, 2026 (9:00 AM IST) and ends on 28th August, 2026 (5:00 PM IST). During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of 22nd August, 2026, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.

- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Pursuant to above said SEBI Circular, Login method for e-Voting and joining virtual meetings for **Individual shareholders holding securities in Demat mode CDSL/NSDL** is given below:

(v) Login method for e-Voting and joining virtual meeting for **Physical shareholders and shareholders other than individual holding in Demat form.**

- 1) The shareholders should log on to the e-voting website www.evotingindia.com.
- 2) Click on "Shareholders" module.
- 3) Now enter your User ID
 - a. For CDSL: 16 digits beneficiary ID,
 - b. For NSDL: 8 Character DP ID followed by 8 Digits Client ID,
 - c. Shareholders holding shares in Physical Form should enter Folio Number registered with the Company.
- 4) Next enter the Image Verification as displayed and Click on Login.
- 5) If you are holding shares in demat form and had logged on to www.evotingindia.com and voted on an earlier e-voting of any company, then your existing password is to be used.
- 6) If you are a first time user follow the steps given below:

- (vi) After entering these details appropriately, click on "SUBMIT" tab.
- (vii) Shareholders holding shares in physical form will then directly reach the Company selection screen. However, shareholders holding shares in demat form will now reach 'Password Creation' menu wherein they are required to mandatorily enter their login password in the new password field. Kindly note that this password is to be also used by the demat holders for voting for resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential.
- (viii) For shareholders holding shares in physical form, the details can be used only for e-voting on the resolutions contained in this Notice.
- (ix) Click on the EVSN for the relevant Company Name i.e. **PREMIER CRYOGENICS LTD.** on which you choose to vote.
- (x) On the voting page, you will see "RESOLUTION DESCRIPTION" and against the same the option "YES/NO" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- (xi) Click on the "RESOLUTIONS FILE LINK" if you wish to view the entire Resolution details.

- (xii) After selecting the resolution, you have decided to vote on, click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- (xiii) Once you "CONFIRM" your vote on the resolution, you will not be allowed to modify your vote.
- (xiv) You can also take a print of the votes cast by clicking on "Click here to print" option on the Voting page.
- (xv) If a demat account holder has forgotten the login password then Enter the User ID and the image verification code and click on Forgot Password & enter the details as prompted by the system.
- (xvi) There is also an optional provision to upload BR/POA if any uploaded, which will be made available to scrutinizer for verification.
- (xvii) **Additional Facility for Non – Individual Shareholders and Custodians –For Remote Voting only.**
- Non-Individual shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on to www.evotingindia.com and register themselves in the "Corporates" module.
 - A scanned copy of the Registration Form bearing the stamp and sign of the entity should be emailed to helpdesk.evoting@cdslindia.com.
 - After receiving the login details a Compliance User should be created using the admin login and password. The Compliance User would be able to link the account(s) for which they wish to vote on.
 - The list of accounts linked in the login will be mapped automatically & can be delink in case of any wrong mapping.

 - Alternatively Non Individual shareholders are required mandatory to send the relevant Board Resolution/ Authority letter etc. together with attested specimen signature of the duly authorized signatory who are authorized to vote, to the Scrutinizer at email address viz; chandancsp@rediffmail.com and to the Company at the email address viz; info@premiercryogenics.com, if they have voted from individual tab & not uploaded same in the CDSL e-voting system for the scrutinizer to verify the same.

INSTRUCTIONS FOR SHAREHOLDERS ATTENDING THE AGM THROUGH VC/OAVM & E-VOTING DURING MEETING ARE AS UNDER:

1. The procedure for attending meeting & e-Voting on the day of the AGM is same as the instructions mentioned above for e-voting.
2. The link for VC/OAVM to attend meeting will be available where the EVSN of Company will be displayed after successful login as per the instructions mentioned above for e-voting.
3. Shareholders who have voted through Remote e-Voting will be eligible to attend the meeting. However, they will not be eligible to vote at the AGM.
4. Shareholders are encouraged to join the Meeting through Laptops / IPads for better experience.
5. Further shareholders will be required to allow Camera and use Internet with a good speed to avoid any disturbance during the meeting.
6. Please note that Participants Connecting from Mobile Devices or Tablets or through Laptop connecting via Mobile Hotspot may experience Audio/Video loss due to Fluctuation in their respective network. It is therefore recommended to use Stable Wi-Fi or LAN Connection to mitigate any kind of aforesaid glitches.
7. Shareholders who would like to express their views/ask questions during the meeting may register themselves as a speaker by sending their request in advance at least **2 (two) days (48 hours) prior to meeting** mentioning their name, demat account number/folio number, email id, mobile number at info@premiercryogenics.com. The shareholders who do not wish to speak during the AGM but have queries may send their queries in advance **2 (two) days (48 hours) prior to meeting** mentioning their name, demat account number/folio number, email id, mobile number at info@premiercryogenics.com. These queries will be replied to by the company suitably by email.
8. Those shareholders who have registered themselves as a speaker will only be allowed to express their views/ask questions during the meeting.
9. Only those shareholders, who are present in the AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system available during the AGM.

10. DEAR MEMBERS,

We have the pleasure in presenting the Thirty-second Annual Report and the Audited Financial Statements of the Company for the year ended 31st March, 2026.

OPERATIONAL PERFORMANCE

During the year 2025-26, the Company's overall operational performance was satisfactory. It could maintain uninterrupted operations and run the manufacturing units optimally aligned to the market demand for its Industrial and Medical gas products. In spite of a competitive environment, the Company could retain its market position and supply its products and services satisfactorily throughout the year. While demand for Nitrogen and Medical Oxygen was about the same compared to the previous year, demand for Industrial oxygen was lower during the year. But growth was seen in the production and sale of Liquid Oxygen, Nitrous Oxide and Carbon Dioxide while Dissolved Acetylene production and sales remained about the same compared to the previous year. The Company also continued to carry out construction business in the Healthcare sector. With the recent Government initiatives and upcoming projects in the industrial and healthcare sectors, the Company remains hopeful of growth in demand for its products and services and better operational performance in the years to come.

FINANCIAL PERFORMANCE

During the year under review, the Company's revenue from operations was ₹8899 lakh which grew by about 19% compared to ₹7465 lakh of the previous year. This was mainly because of increase in revenue from sales by about 10% as well as contribution from increase in Income from construction and other operating income. Profit before tax of ₹2056 lakh showed growth by about 24% compared to ₹1659 lakh of previous year while Net profit after tax of ₹1581 lakh was higher by about 21% compared to ₹1303 lakh of the previous year. The growth in profitability was mainly due to growth in turnover and decrease in Finance cost, power cost and administrative expenses, although there has been increase in some items of expenses like cost of materials consumed, purchases of stock-in-trade, and distribution expenses. With the prospects for growth in market demand and scale of operations, the Company expects that its overall financial performance will improve in the coming years.

BOARDS' REPORT (Contd.)

The Company has been maintaining excellent track record with banks. The Company is availing working capital facilities from SBI. From the end of the financial year till the date of this report, the Company has been timely servicing the aforesaid term loan and working capital facilities as before. During the year under review, the Company was rated "BBB+" by the rating agency CARE for the Company's borrowings.

The financial statements for the year ended March 31, 2026 has been prepared in accordance with the Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 read with the Companies (Accounts) Rules, 2014. The estimates and judgments relating to the Financial Statements are made on a prudent basis, so as to reflect in a true and fair manner, the form and substance of transactions and reasonably present the Company's state of affairs, profits and cash flows for the year. The Notes to the financial statements adequately cover the standalone and consolidated Audited Statements which are made an integral part of this report.

There are no material changes and commitments affecting the financial position of the Company from the end of the financial year to the date of this report.

STATE OF AFFAIRS OF THE COMPANY

During the year under review, the Company was engaged in the business of manufacture, trading, services and construction of facilities of industrial & medical gases. The Company satisfactorily carried out its operations of industrial and medical gases and uninterrupted supplies could be made to the clients, mostly from the core sector oil & gas, hospitals, food and beverage industries and in the infrastructure sector mainly within the N E Region and nearby states. The Company's products are Oxygen, Nitrogen, Dissolved Acetylene, Nitrous Oxide and Carbon Dioxide which in the aggregate contributed revenue of 74.15% of the Company's total turnover during the year. Revenue from services was 4.37% of the total turnover. Other Operating revenue consisting of Government grants and GST refunds contributed about 11.20% while Income from construction was 10.28% of the total turnover. There has been no change in the nature of business of the Company during the year.

FUTURE PLANS & PROSPECTS

In recent years, the State has witnessed commendable initiatives taken by the Government for rapid industrialization, which has brought prospects for sustainable growth and development in the near future. Possible growth is anticipated in sectors like electronics, power and infrastructure where mega corporate projects have been initiated, in addition to the Government initiated projects in the core sector oil industries, railways, health care, tourism and hospitality. In this perspective, the Company foresees good scope for growth in its gas business in the industrial and healthcare sectors in the coming years. To tap the emerging opportunities, the Company is putting its best efforts for capacity building to improve its scale of operations and position itself in the evolving business environment. To meet the future growth in demand, special efforts are being made to set-up new Oxygen/ Nitrogen/ Argon units at Jagiroad in middle Assam and position the Company to tap potential markets for industrial and medical gases across the N.E. Region and beyond. The Company also looks forward for good growth in its construction business in the health care and oil sectors. With adequate engineering capabilities and technical expertise of successfully executing several industrial infrastructure and pipeline projects, the Company remains hopeful of bagging similar contracts in this specialized area. However, the Company keeps itself open to realign its activities as per the industry demands and reassess the impact on its business operations, which may tend to deviate from its current estimates and assumptions. The Company is hopeful that with growing industrial activities together with proactive policies of the Government, it will have much better prospects for growth and development in the coming years.

DIVIDEND

The Board of Directors are pleased to recommend a dividend of 15% per share, ie., ₹ 1.50 per share on the 49,23,900 fully paid up Equity Shares of ₹ 10 each for the financial year 2025-2026.

TRANSFER TO INVESTOR EDUCATION & PROTECTION FUND

During the year under report, the Company transferred the amount of dividend lying unpaid or unclaimed for a period of seven years to the Investor Education & Protection Fund (IEPF). Further, pursuant to the provisions of Section 124(6) of the Companies Act, 2013, all shares in respect of which unpaid or unclaimed dividend has been transferred as aforesaid has also been transferred by the Company in the name of IEPF Authority except the shares of those investors who have communicated with the company before such transfer.

TRANSFER TO RESERVES

The Company proposes to transfer ₹200.00 lakh to the General Reserve out of amount available for appropriation and ₹1248.80 lakh is proposed to be retained in the Statement of Profit and Loss.

PARTICULARS OF LOANS, GUARANTEES AND INVESTMENTS

The Company has not given any loan, guarantee or provided any security in connection with a loan to any person or other body corporate during the year. Current investments of surplus funds were made in Mutual Fund and bank fixed deposits. Advances given to suppliers, Govt. depts., etc. were in the ordinary course of business. Advances to related parties were not material in nature. Details of loans, guarantees and investments covered under the provisions of Section 186 of the Act are given in the notes to Financial Statements forming part of this Annual Report.

The Company is availing working capital (cash credit) facilities of a limit of ₹600 lakh and a bank guarantee limit of ₹1000 lakh from SBI. The Company is also availing under Arogyam scheme cash credit of ₹800 lakh. The Company has not made any application nor is any proceeding pending under the Insolvency and Bankruptcy Code, 2016 during the year. Further, there is no proposal for one time settlement of any loan taken from any Banks or FIs. The Company has been timely servicing the aforesaid term loan and working capital facilities.

ISSUE OF SHARES

During the year, the Company did not make any issue of shares. As on 31st March, 2026, the issued, subscribed and paid-up share capital was ₹492 lakh comprising 49,23,900 equity shares of ₹10/- each. The shares continued to be listed on the Calcutta Stock Exchange and Listing fees have been paid for the year 2025-26. The Company has arrangements with NSDL and CDSL to provide the facility to shareholders for dematerialization of their shares.

DEPOSITS

The Company has not accepted deposits in terms of Section 73 of the Companies Act, 2013 read with Companies (Acceptance of Deposits) Rules, 2014.

HOLDING, SUBSIDIARY & ASSOCIATE COMPANIES

The Company does not have any holding, associate or joint venture company other than a subsidiary company, viz., PCL Power Pvt. Ltd. which is yet to commence its operational activities. The Company is not a material subsidiary as per the threshold laid down under the Listing Regulations. The Company has a policy for determining material subsidiary and the same is available in the Company's website: www.premiercryogenics.com.

PERFORMANCE OF SUBSIDIARY COMPANY

PCL Power Private Limited was incorporated as a subsidiary company primarily with the objective of venturing into the business of generating power by procuring Natural gas from the Oil sector companies. The Company carried out surveys and has been exploring the possibilities of procuring Natural gas to generate power. Bids were submitted to the Oil & Gas sector Companies but the Company could not succeed so far. Efforts are being continued and the Company is hopeful of being successful in its bids and commence operations. The Company is also exploring the possibility of venturing into the solar power business.

In accordance with the provisions of the first proviso to Section 129(3) read with Rule 5 of the Companies (Accounts) Rules, 2014, a statement containing salient features of the financial statement of the Subsidiary Company in prescribed Form AOC-1 is given in Annexure – I.

RELATED PARTY TRANSACTIONS

During the year 2025-26, the Company continued with its contract/arrangement dated 01/04/2024 with M/s. Assam Air Products Pvt. Ltd. (CIN:U24111AS1986PTC002497), a related party, for sale of industrial gases for a period of three years, which was entered after obtaining approval of the Members in General Meeting preceded by approval of the Audit Committee and of the Board in accordance with the provisions of Section 188 of the Companies Act, 2013, Rules thereunder and the SEBI Listing Regulations. Under the contract/arrangement, the total value of transactions was approved for three years subject to maximum total amount per annum of Rs.15.00 Cr. for the year 2024-25, Rs.20.00 Cr. for the year 2025-26 and Rs.25.00 Cr. for the year 2026-27. These incremental limits were fixed in view of the projections and estimates of future growth in demand and scale of operations of the Company.

The Company also continued with its contract/arrangement dated 01/04/2025 with the aforesaid related party for a period of one year i.e., 2025-26 for availing services of installation and commissioning in the execution of supply, installation and commissioning contracts of PSA Oxygen plants in Medical colleges and hospitals across India subject to a maximum total value of Rs.6.00 Cr. For the year 2026-27, the Company proposes to enter into similar contract/arrangement with the related party for one year for purchase of goods and services subject to maximum total value of Rs.6.00 Cr. MANAGEMENT DISCUSSION & ANALYSIS

MANAGEMENT DISCUSSION & ANALYSIS

OVERVIEW:

During the year 2025-26, the overall performance of the Company was satisfactory. It could maintain uninterrupted operations and run the manufacturing units optimally aligned to the market demand for its Industrial and Medical gas products. In spite of a competitive environment, the Company could retain its market position and supply its products and services satisfactorily throughout the year. Total production from the Oxygen/Nitrogen plants was 240.52 lakh cum which was about the same compared 239.95 lakh cum of the previous year. The Company's Nitrogen production during the year was about 100 lakh cum, which was about the same compared to 99.38 lakh cum compared to the previous year. Sale of Nitrogen aggregating 134.63 lakh cum, mainly to the oil sector, grew by about 2% compared to 132.52 lakh cum of previous year. Oxygen production during the year was 140.48 lakh cum which was about the same compared to the previous year. Industrial Oxygen gas sale of 13.13 lakh cum decreased by about 16% while sale of Medical Oxygen gas of 21.30 lakh cum was about the same compared to the previous year. Sale of Liquid Oxygen during the year was 98.69 lakh cum which improved by about 3% compared to previous year. Dissolved Acetylene sale of 1.34 lakh cum increased by 1% while Nitrous Oxide sale of 1.68 lakh cum improved by about 17% over the previous year. Sale of Carbon Dioxide of 7.50 lakh kg increased by about 10% compared to 6.79 lakh kg of the previous year. The Company also continued to carry out construction business in the Oil & Gas and medical sectors which contributed towards the Company's operational performance and improved its scale of operations. With the recent Government initiatives and upcoming projects in the industrial and healthcare sectors, the Company remains hopeful of growth in demand for its products and services and better performance in the coming years.

INDUSTRY STRUCTURE & DEVELOPMENTS:

Premier Cryogenics has been operating for about three decades in the industrial gases industry. During this period, the Company has gained rich experience and adequate expertise in the industrial and medical gas sectors. It has been able to meet the market demands and tap potential markets that have emerged within the NE Region and beyond. Over the years, the Company could capitalize its long standing experience and technical expertise with proven track records in the field of gas production, distribution, bottling and construction of facilities in the oil & gas and healthcare sectors and has been able to operate successfully. The Company is presently catering to a wide range of consumers from the core sector oil industries, State Vety. deptts, research laboratories, Railways, Food processing, Infrastructure and Health care sectors and maintain its leading position mainly in the N.E. region. The Company is presently catering to about 70% of the regional market demand. The Company is also carrying out contractual projects relating to construction of facilities in the gas sector and has been successfully executing several pipeline and infrastructure projects in the oil & gas industries and setting up of PSA Oxygen plants in several medical establishments across the N.E. region. With the recent initiatives taken by the Government for overall industrial development in the State, the Company foresees a rapid growth in demand for its products and services. To tap the emerging opportunities, the company is putting untiring efforts towards capacity building and position itself in the evolving business environment. Initiatives have been taken for setting up a new Nitrogen/Oxygen/Argon production unit in middle Assam to meet the future growth in demand for its products and services and improve its scale of operations thereby maintaining its leading position and successfully operate in the evolving industrial scenerio. The Company is hopeful that the recent Government initiatives for sustainable industrial development in the State will go a long way in bringing rapid growth in the industrial gas market in the years to come.

OPPORTUNITIES, THREATS, RISKS & CONCERNS:

Being in a specialized industry, the Company identifies several significant opportunities. But at the same time, it is also exposed to various threats and risks specific to the industry. The main products, Oxygen & Nitrogen are produced by atmospheric air separation having no raw-material cost. Sale of Dissolved Acetylene has the potential of increasing Oxygen sale due to their joint applications. The Company has the locational advantage of having its manufacturing facilities at Guwahati, the hub centre of the region, and at Samaguri in middle Assam and enjoys comparatively lower freight cost and stable power supply. The Samaguri unit being a latest technology energy efficient plant, the Company enjoys comparatively lower power cost reducing the unit cost of production and giving competitive advantage. The promoters being

MANAGEMENT DISCUSSION & ANALYSIS (Contd.)

highly experienced technocrats, the Company has the potential for growth and development. The gas products being critical inputs for the industrial and medical gas users have good growing demand.

In spite of the opportunities, the Company takes into consideration certain potential risks and threats specific to the industry. Manufacture of O₂/N₂ is critically dependent on power. Any disruption in its supply will adversely affect production. Further, any hike in tariff will inflate the unit cost of products. Calcium Carbide, a major input for DA, is sourced from distant States having the risk of erratic supply and price escalation. The Company supplies mainly through open tenders which are subject to market competition. The Company enjoys benefits relating to tax refunds and other incentives as per the Government Industrial policies. Any change in policy or non-receipt of incentives will affect performance. The Company's business activities are critically dependent on the economic activities of several core sector industries. Any adversities in their performance will have an impact on the Company's performance. With the improvements seen in the overall industrial scenario of the State supported by proactive policies of the Government, the Company remains confident of overcoming the challenges of potential risks and threats and carry out its business operations satisfactorily.

SEGMENT WISE OR PRODUCT WISE PERFORMANCE:

The Company operates in a single business or geographical segment engaged in the business of manufacture, trading, services and construction of facilities of industrial and medical gases. All the activities of the Company are in India and hence in a single geographical segment. The Company's main products include Nitrogen, Oxygen, Dissolved Acetylene and Nitrous Oxide. During the year, Sale of Nitrogen of 134.63 lakh cum which was sold mainly to customers from the Oil sector grew by about 2% compared to 132.52 lakh cum of the previous year. Industrial Oxygen gas sale of 13.13 lakh cum dropped by about 16% while Medical Oxygen gas sale of 21.30 lakh cum was about the same compared to the previous year. But Liquid Oxygen sale of 117.93 lakh cum grew by 20% compared to the previous year. Dissolved Acetylene sale of 1.34 lakh cum increased by 1% over the previous year while sale of Nitrous Oxide of 1.68 lakh cum improved by 17%. Sale of Carbon Dioxide of 7.50 lakh kg increased by about 10% compared to the previous year. The Company is hopeful that the thrust for rapid industrial development in the State initiated by the Government will generate better market demand for the Company's products and services and will enable to further improve its performance in the coming years.

INTERNAL CONTROL SYSTEMS:

The Company has adequate internal control systems commensurate with the nature and size of its business. The control systems are reviewed periodically and are improved upon as per requirement of the activities, particularly relating to sale of goods, purchase of stores, raw materials and other assets in line with the Company's policy on risk management. The Company has installed computer based systems with requisite software for specific job execution processes and on-line facilities were used in all the functional units. These measures have resulted in better internal checks and controls and facilitate real-time reporting and recording of transactions. The internal control system is supplemented by regular internal audits. Review of actions taken on the audit observations are done periodically.

The internal audit report and financial statements are reviewed by the Audit Committee of the Company on a quarterly basis. The observations of the Committee are acted upon by the Management. This has improved the Company's internal reporting process and its review and monitoring systems.

FINANCIAL PERFORMANCE:

During the year, the Company's overall financial performance was satisfactory. It could maintain financial stability and liquidity in its operations, carry out the fiscal plans and policies and meet its financial commitments on time. Adequate systems were put in place for regular monitoring and analysis of the fund flows including supply credits, recoveries, debts and repayments. The Company's annual revenue from operations of ₹8899 lakh grew by about 19% over the previous year mainly due to demand for Nitrogen, Liquid Oxygen, Nitrous Oxide, Carbon Dioxide and Construction business. Profit before finance cost, depreciation and amortization was ₹2661 lakh and net profit before tax of ₹2056 lakh was higher by about 17% and 24% respectively compared to the previous year mainly due to growth in sales and decrease in Finance cost, power cost and other Administrative expenses in spite of increase in some major items of expenses like Cost of materials consumed, purchase of stock-in-trade and distribution expenses. The

Company has been maintaining profitability and paying dividend continuously for last several years. The key indicators of the Company's performance compared to earlier years are annexed to this report. With improvement in the general economic conditions and growing industrial activities, the Company expects better financial performance in the years to come.

The Company has been maintaining excellent track record with banks and timely servicing its term loan from SBI. Working capital is being availed from SBI with cash credit facility of ₹600 lakh and a Non-fund based (bank guarantee) limit of ₹1000 lakh. The Company is also availing under Arogyam scheme cash credit of ₹800 lakh. The Company has a credit rating of "BBB+" from the credit rating agency CARE for the Company's borrowings.

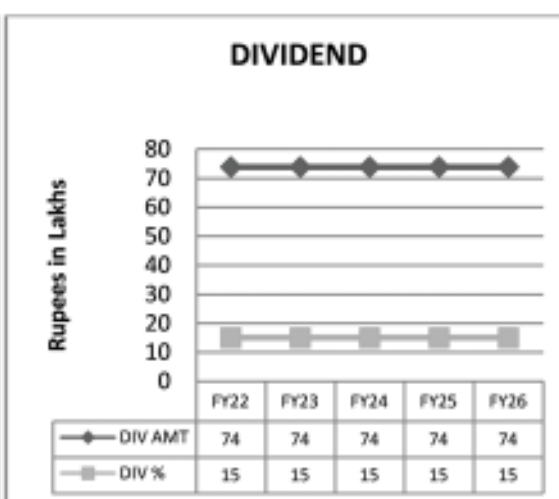
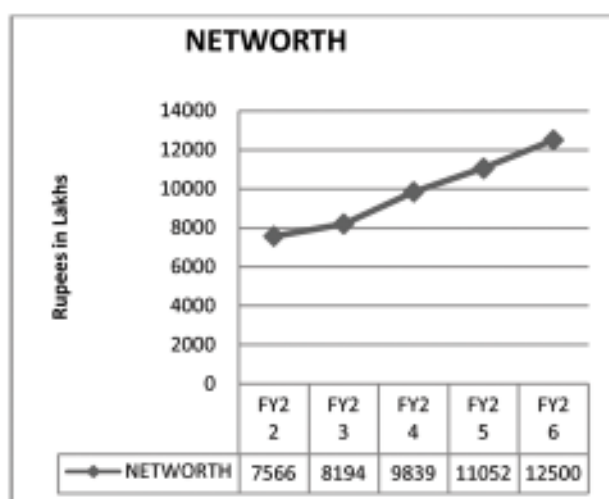
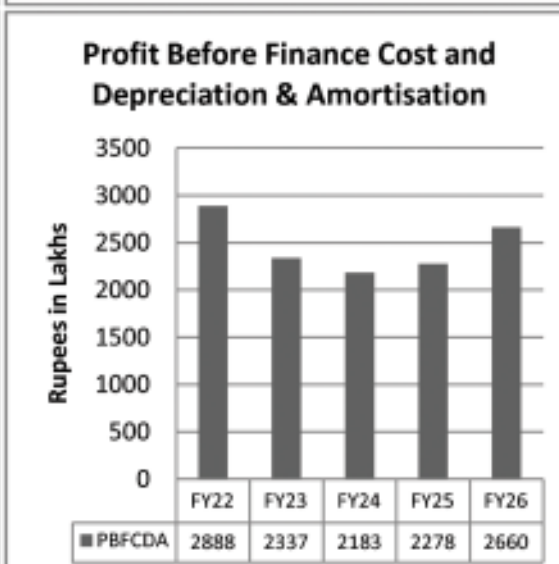
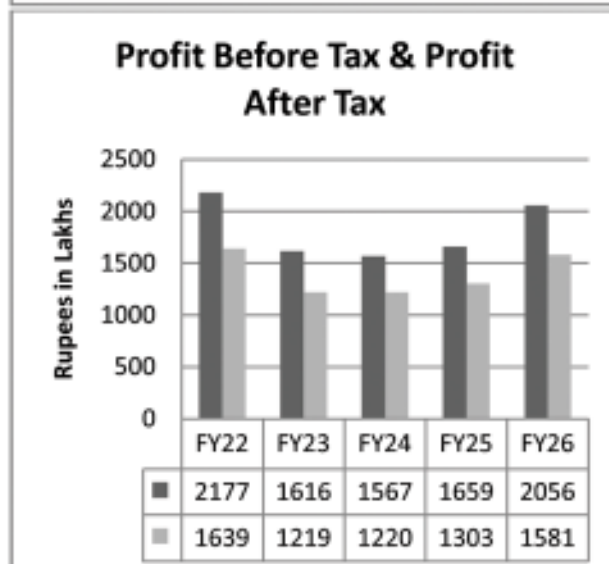
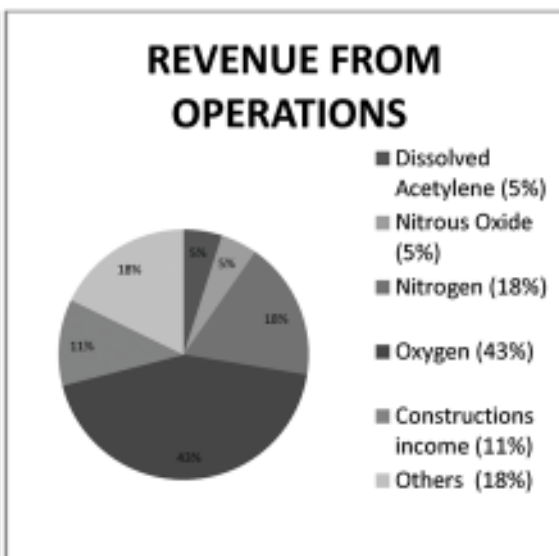
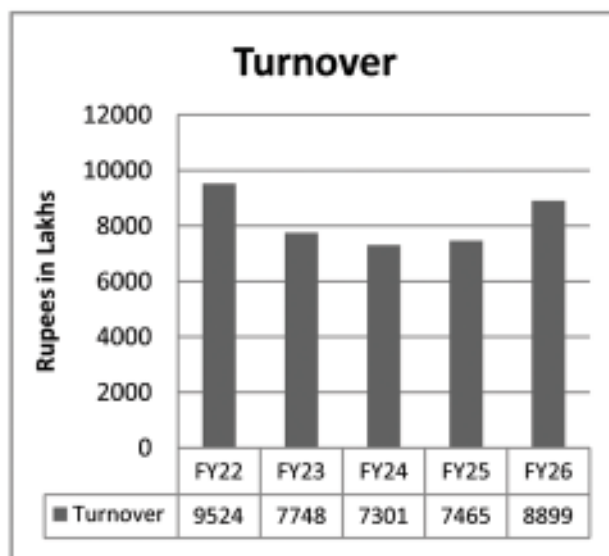
INDUSTRIAL RELATIONS & HUMAN RESOURCE MANAGEMENT:

The Company's Nomination and Remuneration Committee oversees the HR practices as per laid down policies. Relationships with employees were cordial throughout the year. The Directors acknowledge the efforts put in by the employees to improve the Company's level of performance during the year.

CORPORATE POLICIES AND REPORTS

In accordance with the provisions of the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company adopted a Whistle Blower policy as a part of vigil mechanism, policy for managing risks, policy for Nomination and Remuneration, code for dealing in share and fair conduct; dealing with related party transactions, policy for determining material subsidiary, Corporate Social Responsibility policy, Documents preservation policy and a Code of conduct for the Company. Disclosure about the Company's policies and reports are given below:

Whistle Blower Policy

The Company has adopted a Whistle Blower Policy as a part of vigil mechanism to provide the Directors and employees in senior management of the Company with a mechanism to bring to the attention of the management any issue which is perceived to be in violation of or in conflict with the fundamental business principles and code of conduct of the Company. The policy provides for reporting such concerns through written communications to the Company and also makes provision for giving access to the Chairperson of the Audit Committee in appropriate and exceptional cases. Any case registered by the Company under the policy shall be subject to the review of the Audit Committee.

Policy on Risk Management

The Company has a Risk Management procedure based on its assessment of business risks generally and those specific to the industry. The policy on risk management has been formulated keeping in view the size of the Company and nature of its business and in line with the requirements of the Companies Act, 2013 and the Listing Regulations. It enables the Company to assess the risks identified through the business processes and functions, and address the same through mitigating actions in a systematic manner and on a continual basis. Some of the identified risks relate to the economic adversities, competitive intensity and cost volatility. It takes into consideration a variety of risk factors such as market conditions, distribution and supply systems, geographical and social factors, financial, technical, legal and other compliance related factors. During the year, the Company could maintain uninterrupted operations by identifying and aligning its facilities to meet the varying demand for its products from the industrial and healthcare sectors. Steps were taken to minimize product loss by positioning its liquid and gas production and storage facilities with the demand pattern which enabled the Company to reduce the risk of a fall in its scale of operations and

maintain optimum product mix. The Company also continued to optimally utilize its engineering capabilities and technical expertise for carrying out its construction business in the oil and gas and healthcare sectors. With these efforts, the Company could maintain a satisfactory level of performance during the year. The Company is operating its new technology plant at Samaguri which has comparatively lower power cost thereby reducing the unit cost of production. It also carries out in-house plant maintenance and development of certain equipment parts as a measure for import substitution and hedging costs. These measures have enabled the Company to remain competitive and reduce the risk of sustainability in a volatile market. Further, in line with the recent Government initiatives for rapid industrialization in the State and to tap the emerging opportunities, the Company is putting its best efforts to be future ready by capacity building and position itself strategically by setting-up a proposed Oxygen/ Nitrogen/ Argon unit at Jagiroad in middle Assam having good connectivity and quality power, thereby enabling it to tap potential markets and remain competitive. The Company also lays emphasis for improvement in its internal control systems commensurate with the size and nature of its business. These systems are reviewed periodically and recommendations by Audit Committee and Audit observations are taken into consideration for strengthening the risk management practices.

Nomination and Remuneration Policy

The Company has adopted a Nomination and Remuneration Policy pursuant to the provisions of the Companies Act, 2013 and the Listing Regulations. This policy has been formulated as a guide relating to appointment, remuneration, retirement and removal of Director(s), Key Managerial Personnel and Senior Management personnel. It inter alia focuses on identifying and ascertaining the integrity, qualification, expertise and experience of the person for appointment. It also lays down the policy on Board diversity, criteria for selection, appointment, remuneration, retirement and removal of Directors and KMPs, the terms and tenure for the Managing Director/Whole-time director and the independent directors. The policy also serves as a guide for the review and evaluation of performance of the Board and of the individual directors. It also covers the senior management personnel and other employees of the Company.

Policy for dealing with related party transactions

As per requirements of the Companies Act, 2013 and Listing Regulations, the Company formulated a policy on Related party transactions to ensure that proper reporting, approval and disclosure processes

are in place for the transactions between the Company and related parties. The policy deals with the review and approval of material related party transactions keeping in view the conflict of interest that may arise because of entering into these transactions. It guides in ascertaining the materiality of contracts or arrangements entered into by the Company with related parties in relation to the nature and size of the transactions and also those which are carried out in the ordinary course of business or relating to arm's length transactions, if any. The Related party transactions are placed before the Audit Committee for review and approval of the Board and Shareholders and disclosed as per provisions of the Companies Act, 2013, the rules thereunder and the Listing regulations.

Policy for determining material subsidiaries

As per Regulation 16(1)(c) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had formulated a policy for determining material subsidiaries, as may be required from time to time. The policy has been adopted to determine the material subsidiary(ies) of the Company upon identifying the same and to provide the governance framework for such subsidiary company(ies). It inter alia defines the materiality of a subsidiary, representation on its board, role of the Company's Audit Committee relating to its subsidiary, role of the management, and disposal of the material subsidiary.

Code of fair disclosure and conduct

Pursuant to the SEBI Regulations on prohibition of insider trading, the Company has adopted the Code for fair disclosure and conduct to establish a mechanism to restrict insider trading in shares of the Company. The Code prohibits the Directors of the Company and other specified employees dealing in the securities of the Company on the basis of any unpublished price sensitive information, available to them by virtue of their position in the Company. The Code prevents misuse of any unpublished price sensitive information and prohibits any insider trading activity, in order to protect the interest of the shareholders of the Company.

CSR Policy

In accordance with the provisions of Section 135 of the Companies Act, 2013 read with Rule 3 of the Companies (Corporate Social Responsibility Policy) Rules, 2014 and Rule 9 of the Companies (Accounts) Rules, 2014, the Company had earlier constituted a CSR Committee and also adopted a policy on CSR. The Company's CSR policy is a guide for conducting its business with social responsibility and accountability. It lays down a

systematic and dedicated approach towards implementing CSR projects or programmes for improving the quality of life of the people and society primarily in the areas in which it operates. It describes the focus areas and the methodology for implementation, governance, funding, monitoring and reporting the activities.

During the year 2025-26, the Company undertook CSR activities in the areas of Environmental sustainability, Education and training, Rural road development, etc. The activities were carried out in the Districts of Kamrup (Metro), Nagaon, Dibrugarh and Sivasagar Assam where the Company has its business operations. As per the aforesaid provisions, an Annual report on the CSR activities carried out during 2025-26 is annexed to the Board's report.

Document Preservation and Archival Policy

In accordance with Regulation 9 of the SEBI Listing Regulations, the Company has framed a Policy for Preservation and Archival of Documents. We, however, state that this is not an assurance as to the future viability of the Company. We further state that our reporting is based on the facts up to the date of the audit report and we neither give any guarantee nor any assurance that all liabilities falling due within a period of one year from the balance sheet date, will get discharged by the Company as and when they fall due.

xx) (a) There are no unspent amounts towards Corporate Social Responsibility (CSR) on other than ongoing projects requiring a transfer to a Fund specified in Schedule VII to the Companies Act in compliance with second proviso to sub-section (5) of Section 135 of the said Act. Accordingly, reporting under clause 3(xx)(a) of the Order is not applicable for the year.

NOTES TO FINANCIAL STATEMENTS

Notes to the financial statements for the year ended March 31, 2026

1. Company Information

Premier Cryogenics Limited (the 'Company') is a public limited company domiciled in India with its registered office at 136, Maniram Dewan Road, Chandmari, Guwahati 781 003. The Company is listed on the Calcutta Stock Exchange (CSE). The Company is operating in the Industrial & Medical Gases business comprising primarily of Oxygen, Nitrogen, Medical oxygen, Nitrous oxide, Dissolved Acetylene in Eastern India. The Company has manufacturing facilities at Guwahati and Samaguri in Assam and sells primarily in Eastern India through independent distributors and direct sales. It also provides services and carries out construction business in Industrial & Medical Gases sector.

2. Basis of Preparation, Measurement and Significant Accounting Policies

2.1 Basis of Preparation

These financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'Ind AS') as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current or non-current classification of assets and liabilities.

The financial statements are presented in INR, the functional currency of the Company. Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates (the 'functional currency').

2.2 Basis of measurement

These financial statements are prepared under the historical cost convention unless otherwise indicated.

2.3 SIGNIFICANT ACCOUNTING POLICIES

a) Property, plant and equipment

Property, Plant and Equipment are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. Such cost includes the cost of replacing part of the Plant and Equipment and borrowing costs for long-term construction projects if the recognition criteria are met. When significant parts of plant and equipment are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives. All repair and maintenance costs are recognised in profit or loss as incurred.

Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as "Capital work-in-progress".

An item of Property, Plant and Equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is derecognised.

Depreciation on Property, Plant and Equipment is provided based on useful life of the assets prescribed in Schedule II to the Companies Act, 2013. However, any deviation from the useful life as prescribed in Schedule II to the Companies Act, 2013 and actual life of the assets shall be disclosed. Depreciation methods, useful lives and residual values are reviewed periodically, including at each financial year end and adjusted prospectively, if appropriate.

b) Intangible assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated amortisation/depletion and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use and net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the intangible assets.

Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in the Statement of Profit or Loss when the asset is derecognised.

Intangible assets comprising of Software are amortised over the period of 5 years.

c) Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/non-current classification.

An asset is current when :

- . Expected to be realised or intended to be sold or consumed in the normal operating cycle;
- . Held primarily for the purpose of trading;

NOTES TO FINANCIAL STATEMENTS (Contd.)

- . Expected to be realised within twelve months after the reporting period ; or
- . Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is current when :

- . It is expected to be settled in the normal operating cycle ;
- . It is held primarily for the purpose of trading ;
- . It is due to be settled within twelve months after the reporting period ; or
- . There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

d) Inventories

Inventories are valued at lower of cost or net realisable value. Cost is determined on weighted average basis. Cost of inventories comprises all costs of purchase, duties and taxes (other than those subsequently recoverable from tax authorities) and all other costs incurred in bringing the inventory to their present location and condition. Cost of finished goods and work-in-progress includes the cost of materials, conversion costs, an appropriate share of fixed and variable production overheads and other costs incurred in bringing the inventories to their present location and condition. Net realisable value represents the estimated selling price in the ordinary course of business less all estimated costs of completion and costs necessary to make the sale.

Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are disclosed under Capital Work-in-Progress.

e) Impairment of Non- Financial Assets

The Company assesses at each reporting date as to whether there is any indication that any property, plant and equipment and intangible assets or group of assets, called cash generating units (CGU) may be impaired. If any such indication exists the recoverable amount of an asset or CGU is estimated to determine the extent of impairment, if any. When it is not possible to estimate the recoverable amount of an individual assets, the Company estimates the recoverable amount of the (CGU) to which the asset belongs. An impairment loss is recognised in the Statement of Profit and Loss to the extent, asset's carrying amount exceeds its recoverable amount. The recoverable amount is higher of an asset's fair value less cost of disposal and value in use. Value in use is based on the estimated future cash flows, discounted to their present value using pre-tax discount rate that reflects current market assessments of the time value of money and risk specific to the assets. The impairment loss recognised in prior accounting period is reversed if there has been a change in the estimate of recoverable amount.

f) Provisions and Contingent Liabilities

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

g) Employee Benefits

Defined Contribution Plans

Provident Fund and ESIC contributions are made to the respective regulatory authorities. The Company makes specified monthly contributions towards Provident Fund and Employees State Insurance Corporation. The Company's contribution is recognised as an expense in the Statement of Profit and Loss during the period in which the employee renders the related service.

Defined Benefit Plans

The Company pays gratuity to the employees whoever has completed five years of service with the company at the time of resignation/superannuation. The gratuity is paid @15 days salary for every completed year of service as per the Payment of Gratuity Act 1972.

The gratuity liability amount is contributed to Life Insurance Corporation of India under Group Gratuity Scheme for employees. The gratuity fund has been approved by respective IT authorities. The liability in respect of gratuity and other post-employment benefits is calculated using the Projected Unit Credit Method and spread over the period during which the benefit is expected to be derived from employees' services.

NOTES TO FINANCIAL STATEMENTS (Contd.)

h) Tax Expenses

The tax expense for the period comprises current and deferred tax. Tax is recognised in the Statement of Profit and Loss, except to the extent that it relates to items recognised in the comprehensive income or in equity. In which case, the tax is also recognised in other comprehensive income or equity.

Current Tax

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates and laws that are enacted or substantively enacted at the Balance sheet date.

Deferred tax

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The carrying amount of Deferred tax liabilities and assets are reviewed at the end of each reporting period.

i) Foreign currencies transactions and translation

Transactions in foreign currencies are recorded at the exchange rate prevailing on the date of transaction. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency closing rates of exchange at the reporting date. Exchange differences arising on settlement or translation of monetary items are recognised in Statement of Profit and Loss.

j) Revenue recognition

Revenue from sale of goods is recognised when all the significant risks and rewards of ownership in the goods are transferred to the buyer as per the terms of the contract, there is no continuing managerial involvement with the goods and the amount of revenue can be measured reliably. The Company retains no effective control of the goods transferred to a degree usually associated with ownership and no significant uncertainty exists regarding the amount of the consideration that will be derived from the sale of goods. Revenue is measured at fair value of the consideration received or receivable, after deduction of any trade discounts and any taxes or duties collected on behalf of the government which are levied on sales such as sales tax, value added tax, goods and services tax, etc.

Income from services rendered is recognised based on agreements/ arrangements with the customers as the service is performed in proportion to the stage of completion of the transaction at the reporting date and the amount of revenue can be measured reliably.

Revenue from EPC is recognised on the basis of stage of completion by reference to surveys of work performed.

Interest income from a financial asset is recognised on time basis, by reference to the principal outstanding at the effective interest rate applicable, which is the rate which exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition. Insurance claims are recognised to the extent there is a reasonable certainty of the realizability of the claim amount.

Dividend income is recognised when the Company's right to receive the payment has been established.

k) Government Grants

Government grants are recognised when there is reasonable assurance that they will be received and the Company will comply with the conditions associated with the grants. Grants that compensate the company for expenses incurred are recognised in profit or loss, either as other operating income or deducted in reporting the related expense, as appropriate, on a systematic basis over the periods in which the Company recognises as expenses the related costs for which the grants are intended to compensate. Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Company with no future related costs are recognised in profit or loss in the period in which they are received. As per Ind AS 20, government grants related to assets, shall be presented in the Balance Sheet by setting up the grant as deferred income. In subsequent year this deferred government grant will be amortised over the useful life of the assets.

l) Financial instruments

Financial Assets

A. Initial recognition and measurement:

All financial assets and liabilities are initially recognized at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities, which are not at fair value through profit or loss, are adjusted to the fair value on initial recognition. Purchase and sale of financial assets are recognised using trade date accounting.

NOTES TO FINANCIAL STATEMENTS (Contd.)

B. Subsequent measurement

i) Financial assets carried at amortised cost (AC)

A financial asset is measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

ii) Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

iii) Financial assets at fair value through profit or loss (FVTPL)

A financial asset which is not classified in any of the above categories are measured at fair value through profit or loss.

m) Equity Investments

All equity investments are measured at fair value, with value changes recognised in statement of profit and loss, except for those equity investments for which the company has elected to present the value changes in 'Other Comprehensive Income'.

n) Impairment of Financial Assets.

In accordance with Ind AS 109, the Company uses 'Expected Credit Loss' (ECL) model, for evaluating impairment of financial assets other than those measured at fair value through profit and loss (FVTPL). Expected credit losses are measured through a loss allowance at an amount equal to :

i. The 12-months expected credit losses (expected credit losses that result from those default events on the financial instrument that are possible within 12 months after the reporting date); or

ii. Full lifetime expected credit losses (expected credit losses that result from all possible default events over the life of the financial instrument)

For trade receivables company applies 'simplified approach' which requires expected lifetime losses to be recognised from initial recognition of the receivables. Further the company uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward looking estimates are analysed. For other assets, the company uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

o) Financial liabilities

Initial recognition and measurement:

All financial liabilities are recognized initially at fair value and in case of loans net of directly attributable cost. Fees of recurring nature are directly recognised in the Statement of Profit and Loss as finance cost.

Subsequent measurement:

Financial liabilities are carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

De-recognition of financial instruments

q) Earnings Per Share

Basic earnings per share is computed by dividing the net profit for the period attributable to the equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period and for all periods presented is adjusted for events, such as bonus shares, other than the conversion of potential equity shares that have changed the number of equity shares outstanding, without a corresponding change in resources.

For the purpose of calculating diluted earnings per share, the net profit for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.

NOTES ON CONSOLIDATED FINANCIAL STATEMENTS

Notes on Consolidated financial statements for the year ended March 31, 2026

1. Company Information

Premier Cryogenics Limited (the 'Company') is a public limited company and its subsidiary domiciled in India with its registered office at 136, Maniram Dewan Road, Chandmari, Guwahati 781 003. The Company is listed on the Calcutta Stock Exchange (CSE). The Company is operating in the Industrial & Medical Gases business comprising primarily of Oxygen, Nitrogen, Medical oxygen, Nitrous oxide, Dissolved Acetylene in Eastern India. The Company has manufacturing facilities at Guwahati and Samaguri in Assam and sells primarily in Eastern India through independent distributors and direct sales. It also provides services and carries out construction business in Industrial & Medical Gases sector.

2. Basis of Preparation, Measurement and Significant Accounting Policies

2.1 Basis of Preparation

These financial statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'Ind AS') as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current or non-current classification of assets and liabilities.

The financial statements are presented in INR, the functional currency of the Company. Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates (the 'functional currency').

2.2 Basis of measurement

These financial statements are prepared under the historical cost convention unless otherwise indicated.

2.3 SIGNIFICANT ACCOUNTING POLICIES

a) Principles of Consolidation

The Consolidated Financial Statement ("CFS") relate to Premier Cryogenics Limited ("the Company") and its subsidiary (the company and its subsidiary collectively referred to as "the Group"). The Consolidated Financial Statement have been prepared on the following basis :

- i) The financial statements of the Company and its subsidiary Companies are combined on a line by line basis by adding together the book values of like items of assets, liabilities, income and expenses, after fully eliminating intra group balances and intra group transactions resulting in unrealised profits or losses in accordance with Indian Accounting Standard 110 - "Consolidated Financial Statements".
 - ii) The consolidated financial statements are prepared to the extent possible by using uniform accounting policies for like transactions and other events in similar circumstances and are presented in the same manner as the Company's separate financial statements except as otherwise stated.
- b) The subsidiary company PCL Power Private Limited is included in the consolidation and the Company's holding therein is 100%

2.4 OTHER SIGNIFICANT ACCOUNTING POLICIES

These are set out under "Significant Accounting Policies" as given in the Company's separate financial statement.
